

FINANCE AMENDMENT

The Finance Committee offers the following amendment to File No. 2025-21:

- (1) On **page 1, lines 9-10, 21, 24 and 26**, **strike** "B.T. 25-025" and **insert** "Revised B.T. 25-025";
- (2) On **page 1, lines 10-11**, **strike** "ONE PUBLIC SAFETY ANALYST AND TWO FUSION CENTER ANALYSTS" and **insert** "TWO JSO FUSION CENTER ANALYST POSITIONS AND 2,080 PART-TIME HOURS WITHIN THE JACKSONVILLE SHERIFF'S OFFICE";
- (3) On **page 1, line 12**, **strike** "R.C. 24-197" and **insert** "REVISED R.C. 24-197";
- (4) On **page 1, line 21**, **strike** "Exhibit 1" and **insert** "Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev B.T. 25-025, February 4, 2025 - Finance"";
- (5) On **page 1, line 30**, **strike** "one public safety analyst and two fusion center analysts" and **insert** "two JSO Fusion Center Analysts and provide 2,080 part-time hours";
- (6) On **page 2, line 5**, **strike** "fusion center analysts and one critical infrastructure specialist" and **insert** "JSO Fusion Center Analysts and provide 2,080 part-time hours";
- (7) On **page 2, line 6**, **strike** "Noertheast" and **insert** "Northeast";
- (8) On **page 2, line 12**, **strike** "On File" and **insert** "Revised On File";
- (9) On **page 2, lines 14-16**, **strike** all lines in their entirety and **insert** a new Section 3 to read as follows:

"Section 3. Authorization of Positions and Part-Time Hours. There are hereby authorized two JSO Fusion Center

Analyst positions and 2,080 part-time hours within the Jacksonville Sheriff's Office as more fully described in Revised R.C. 24-197, attached hereto as **Revised Exhibit 2**, labeled as "Revised Exhibit 2, Rev R.C. 24-197, February 4, 2025 - Finance" and incorporated herein by this reference.";

- (10) On **page 2, lines 17-19, strike** all lines in their entirety;
- (11) Renumber the remaining Sections accordingly;
- (12) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. 25-025 to reflect the removal of the JSO Public Safety Analyst position and authorization of 2,080 part-time hours;
- (13) Remove **Exhibit 2** and replace with **Revised Exhibit 2**, attached hereto, which attaches the revised R.C. 24-197 to reflect the removal of the JSO Public Safety Analyst position and authorization of 2,080 part-time hours;
- (14) Remove **On File** and replace with **Revised On File**, attached hereto, which attaches the Agreement for State Financial Assistance Between Florida Department of Law Enforcement and Jacksonville Sheriff's Office to include all pages;
- (15) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
