7 OF WILFRED A. WILLIAMS AS OPERATIONS DIRECTOR OF  
8 THE CITY OF JACKSONVILLE PURSUANT TO SECTION  
9 32.104 (OPERATIONS DIRECTOR), PART 1 (IN  
10 GENERAL), CHAPTER 32 (PUBLIC WORKS DEPARTMENT),  
11 *ORDINANCE CODE*; WAIVING THE REQUIREMENT OF  
12 SECTION 32.104 (OPERATIONS DIRECTOR), PART 1 (IN  
13 GENERAL), CHAPTER 32 (PUBLIC WORKS DEPARTMENT),  
14 *ORDINANCE CODE*, THAT THE OPERATIONS DIRECTOR BE  
15 REGISTERED BY THE STATE OF FLORIDA AS A  
16 PROFESSIONAL ENGINEER; PROVIDING AN EFFECTIVE  
17 DATE.

19 **BE IT RESOLVED** by the Council of the City of Jacksonville:

20 **Section 1. Appointment.** The Council hereby confirms the  
21 Mayor's appointment of Wilfred A. Williams as Operations Director of  
22 the City of Jacksonville pursuant to Section 32.104 (Operations  
23 Director), Part 1 (In General), Chapter 32 (Public Works Department).  
24 Attached hereto as **Exhibit 1** is the *curriculum vitae* of Wilfred A.  
25 Williams.

26 **Section 2. Waiver of Requirement in Section 32.104**  
27 **(Operations Director), Part 1 (In General), Chapter 32 (Public Works**  
28 **Department), Ordinance Code.** The requirement delineated in Section  
29 32.104 (Operations Director), Part 1 (In General), Chapter 32 (Public  
30 Works Department), *Ordinance Code*, that the Operations Director be  
31 registered by the State of Florida as a professional engineer is

1 hereby waived recognizing that although Mr. Williams is not registered  
2 by the State of Florida as a professional engineer, he does possess  
3 a master's degree in Business Administration and has over six (6)  
4 years of experience as the City's Chief of Solid Waste Division.

5 **Section 3. Effective Date.** This ordinance shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
