WHEREAS, she has been recognized for her strong commitment to public service, professionalism, and the positive relationships she built with residents, colleagues, and community partners; and

WHEREAS, Ms. Wesolowski's dedication, institutional knowledge, and tireless advocacy for Jacksonville's neighborhoods have left a lasting impact that will benefit the community for years to come; now therefore
