4 **RESOLUTION 2025-557**

5 A RESOLUTION REGARDING TRANSPARENCY IN  
6 GOVERNMENT; REQUESTING THE MAYOR, OR HER  
7 DESIGNEE, PROVIDE A REPORT TO THE CITY COUNCIL  
8 FINANCE COMMITTEE ON OR BEFORE OCTOBER 7, 2025,  
9 PERTAINING TO: (1) FEDERAL GRANTS, (2) HOUSING  
10 OF UNAUTHORIZED ALIENS, AND (3) ALL FISCAL YEAR  
11 2024-2025 BUDGETED AND ACTUAL EXPENDITURES, IN  
12 WHATEVER FORM, ON OR TO NON-PROFIT ENTITIES;  
13 PROVIDING AN EFFECTIVE DATE.  
14

15 **WHEREAS,** the City Council has repeatedly stated that  
16 transparency in government is of tantamount importance as it not only  
17 fosters good government, but highlights and bolsters the trust of the  
18 people of Jacksonville in both the operation of this consolidated  
19 government and its stewardship of the taxpayer's dollars; and

20 **WHEREAS,** recently the City Council considered Ordinance 2025-  
21 138 which, in part, sought to further this goal of increased  
22 transparency by requiring the Mayor, or her designee, to provide a  
23 report to the City Council Finance Committee pertaining to federal  
24 grants, policies and practices regarding diversity, equity and  
25 inclusion, housing of unauthorized aliens, and Fiscal Year 2024-2025  
26 budgeted and actual expenditures on or to non-profit entities; and

27 **WHEREAS,** for reasons not centered on the aforementioned report,  
28 Ordinance 2025-138 was vetoed by the Mayor and the veto was sustained  
29 by the City Council on June 24, 2025; and

30 **WHEREAS,** the City Council still finds value in receiving  
31 information regarding federal grants, housing of unauthorized aliens,

1 and Fiscal Year 2024-2025 expenditures on or to non-profits as it can  
2 assist the Council in making a variety of decisions pertaining to  
3 City budgeting, implementation or modification of City policies, and  
4 furtherance of transparency in government; now therefore

5 **BE IT RESOLVED** by the Council of the City of Jacksonville:

6 **Section 1. Request for Report.** The Mayor, or her  
7 designee(s), is hereby requested to present a report to the City  
8 Council Finance Committee on or before October 7, 2025, as follows:

9 a) Federal Grants:

10 (1) Provide a list of all grants between the City of  
11 Jacksonville/Duval County and the federal government and  
12 any of its offices, divisions, agencies, etc. Included in  
13 the report must be a brief description of the grant, the  
14 funding entity, and information as to whether the City has  
15 received notice of any intent to withhold funds or to cease  
16 reimbursement under any grant or if the Mayor or Grant  
17 Administrator anticipates such action to occur.

18 (2) Confirmation that the City of Jacksonville is in compliance  
19 with all applicable federal and state anti-discrimination  
20 laws, rules, regulations and policies. For instances in  
21 which the City is not in compliance with a law, rule,  
22 regulation or policy, the Mayor must outline a plan and  
23 timeline to achieve compliance with such law, rule,  
24 regulation or policy.

25 b) Housing of Unauthorized Aliens:

26 (1) Information regarding the number of unauthorized aliens,  
27 if any, residing in public housing under the jurisdiction  
28 and control of the City or any of its independent agencies.  
29 The term "unauthorized alien" shall have the same meaning  
30 as found in Section 908.111, *Florida Statutes*.

31 c) Expenditures on Non-Profits:

1 (1) Information regarding any and all budgeted and actual  
2 expenditures, in whatever form, on or to non-profit  
3 entities in Fiscal Year 2024-2025.

4 **Section 2. Effective Date.** This Resolution shall become  
5 effective upon signature by the Mayor or upon becoming effective  
6 without the Mayor's signature.
