COMMISSION & IEPB COMMITTEE UPDATES

- Waterways Commission Mr. Baker shared that he was unable to attend the meeting. There was mention of a discussion around derelict vessels.
- KJB Commission Mr. Richardson shared the primary focus of the commission is preparation for their upcoming annual event to be held in the 1st quarter of the year.
- JEPB Water Committee Terry Carr referred everyone to the reports provided with the meeting packet and shared a highlight:
 - EQD recently took part in an audit of the NPDES permit. FDEP expressed much pleasure with the ESC related inspections and enforcement activities. We are awaiting their final report.
- JEPB Air Committee Chief Long referred everyone to the reports provided with the meeting packet and shared a few highlights:
 - o She shared some recent issues with 200 Riverside Ave project and an early morning concrete pour. Staff is gathering information and will determine if any violation of the variance occurred and what might be any ramifications.
 - Air monitoring equipment is being moved around which resulted in some incomplete data. Once everything has been locked in, the data should correct.
- JEPB Education & Outreach Committee Mr. Richardson shared that the committee met and vetted the funding request to be heard later in the meeting.

OPEN VARIANCES

Mr. Richardson referred to the previous discussion of the 200 Riverside Ave variance. He shared that two variances have been closed and there is one which remains open through December 2020. He also shared that he would include the dumpster permits on future reports and that there were no issues with the two currently in place.

EPB ADMINISTRATOR REPORT

Mr. Richardson referred members to the report provided in the packet.

He then shared that the Florida Legislative session is officially underway as the committees begin to meet and legislation being filed. The 2020 session will commence in January and will likely have some environmental issues addressed. In addition, he shared that FDEP is also likely to be implementing several things which might be of

interest to the JEPB including rulemaking on the statewide Stormwater rule. We will monitor everything and keep the members apprised.

Funding Request – UNF Water Quality Modeling Program

Mr. Richardson introduced Dr. Chris Brown, with UNF, to share background information on the funding request seeking \$75,000 to build a water quality module on a hydrodynamic modeling program being built by UNF. The module would be an additional tool that would be of benefit to the City of Jacksonville. He discussed the changes to the request made after meeting with the JEPB EPO Committee. During discussion, Chief Long shared that the tool would be of some value and she hopes to work with Public Works so that they might use it to help prioritize future CIP projects for water quality improvements. In response to questions, she also shared that it was very likely that EQD could benefit from use of the tool with possibly using it to ensure that water quality monitoring stations are properly located.

After some discussion, a motion was made to approve the funding request as presented (Hoyles), was properly seconded (Shirley) and approved by the body.

• JEPB Committee Assignments

Mr. Richardson shared that following her election as Chair, he met with Ms. Fu to discuss roles of the position – a part of which is to appoint members to committees. He shared that she first decided to continue the Education & Public Outreach Committee. He then shared the committee assignments for each of the three Board committees – Air, Water and EPO.

Mr. Richardson then discussed the commissions that have JEPB members participating – Jacksonville Waterways Commission and the Keep Jacksonville Beautiful Commission. He indicated that members usually volunteer, however if no one steps forward, the Chair will select. Ms. Shirley volunteered to be the KJB representative and Mr. Hoyles volunteered to be the JWC representative.

Environmental Protection Fund Request for Funding Assistance UNF WATER QUALITY MODELING PROGRAM MODULE

Purpose

This legislation would provide for the following:

- Appropriation of \$74,993 from the Environmental Protection Fund (EPF) which is administered by the Environmental Protection Board (EPB).
- Authorization of contract with the University of North Florida (UNF) to build a water quality module on a hydrodynamic modeling program
- Payments as outlined in the Scope of Work
- An exemption from Section 126.107(g) of the Procurement Code to allow a contract with an entity (UNF) specifically prescribed in the legislation.

Background

The Fund, which was created in 1984, was established under the Board's purview to be used by the Board for the purposes described in <u>Section 360.602</u> O.C. The established purposes for use of the Fund include:

- Restoration of polluted areas subject to Board actions.
- Restoration where costs exceeded amount recovered from responsible party in judicial or administrative proceedings.
- To recover the costs and expenses of the Board in administering the Fund.
- To pay for removal (emergency) or remedial actions (cleanup).
- To fund education and outreach activities, studies, surveys, tests and investigations pertaining to the duties of the Board.

Sources of Fund revenue include:

- Fines collected by the City
- Moneys received as a result of an administrative or judicial proceeding
- Moneys recovered as punitive damages
- Moneys recovered as civil penalties

Description

The University of North Florida (UNF) is currently in the midst of developing a surface water simulation model for the St. Johns River. The primary model under development is a hydrodynamic model of the Lower St. Johns River watershed with a focus on Duval County that will be able to incorporate rainfall-driven flows, tides, storm surge, sea level rise, and future urbanization for the purposes of evaluating many water resources and water quality problems that will likely occur within the watershed. The hydrodynamic model will be coupled to an ocean model as well as sub-basin hydrologic models so that the model will realistically reproduce expected flow rates, flow direction, salinity, and water quality within the watershed.

During development and review of the agreement between UNF and the City, the impact of COVID delayed the original timeframes. After consultation with UNF, the timeline was adjusted to allow for the return of faculty and student assistants.

Project Goals

UNF is integrating existing hydrologic and flow models to the extent practical including data from the St. Johns River Water Management District (SJRWMD), City of Jacksonville, UNF/JU, and private firms in order to speed development of the new state-of-the-art model as well as to ensure the lowest development cost possible. Once the model has been calibrated and validated, it is expected that the new model will be an ideal tool for the evaluation of nutrient and toxics reduction within the City of Jacksonville. The tool will help identify opportunities to prioritize future CIP projects for water quality improvements. It may also assist future resiliency efforts as well.

Funding

- The EPB has authorized funding, pursuant to Section 111.755 and 360.602 O.C., in the amount of \$74,993 to support the project. The EPB unanimously approved the project at its December 2019 meeting.
- The Environmental Protection Trust Fund, which was created in 1984, was established under the Board's purview to be used by the Board for the purposes described in <u>Section 360.602</u> O.C. The primary established purposes for use of the Fund include:
 - o Restoration of polluted areas subject to Board actions.
 - Restoration where costs exceeded amount recovered from responsible party in judicial or administrative proceedings.
 - o To recover the costs and expenses of the Board in administering the Fund.
 - To pay for the removal (emergency) or remedial actions (cleanup).
 - o To fund education and outreach activities, studies, surveys, tests and investigations pertaining to the duties of the Board.

 - Moneys recovered as civil penalties
