RESOLUTION 2023-153

A RESOLUTION RECOGNIZING MARCH AS NATIONAL RED CROSS MONTH AND COMMEMORATING THE 142ND ANNIVERSARY OF THE AMERICAN RED CROSS AND THE 109TH ANNIVERSARY OF THE NORTHEAST FLORIDA CHAPTER OF THE AMERICAN RED CROSS; COMMENDING THE VOLUNTEERS AND PAID STAFF OF THE NORTH FLORIDA REGION FOR THEIR CONTINUING HUMANITARIAN SERVICE TO OUR CITY AND TO THE STATE OF FLORIDA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the American Red Cross is a humanitarian organization founded in 1881 and originally chartered by Congress as a federal instrumentality in 1900, but receives no federal funding; and

WHEREAS, the American Red Cross prevents and alleviates human suffering in the face of emergencies by mobilizing the power of volunteers and the generosity of donors; and

WHEREAS, the American Red Cross responds to more than 60,000 disasters annually, delivers vital services to members of the Armed Forces, their families, and Veterans at home and overseas, and provided lifesaving health and safety training to more than 4.6 million people in 2022; and

WHEREAS, March is recognized as Red Cross Month across the nation and 2023 marks the $142^{\rm nd}$ anniversary of the American Red Cross and the $109^{\rm th}$ anniversary of Florida's first chartered Red Cross Chapter, established here in Jacksonville, Florida; and

WHEREAS, the American Red Cross has repeatedly answered the call to assist Northeast Florida, beginning with the Yellow Fever

epidemic of 1888, offering support in Jacksonville to American troops during the Spanish American War, then later providing relief to those affected by Jacksonville's Great Fire of 1901; and

WHEREAS, the Northeast Florida Chapter of the American Red Cross provides its humanitarian services across 13 counties in Northeast Florida and is the headquarters for the 35-county Red Cross North Florida Region stretching from the First Coast across the entire breadth of the Florida Panhandle; and

WHEREAS, in 2022, the Northeast Florida Chapter of the American Red Cross helped over 1,900 family members affected by nearly 600 home fires or other disasters, hosted 60 blood drives throughout the region, including collections targeted at Sickle Cell Disease and vital minority blood-type collections, regionally provided more than 18,600 vital services to military members, veterans, and families, and deployed more than 200 of its 1,100 volunteers in response to hurricanes and other disasters; and

WHEREAS, the American Red Cross and its Northeast Florida Chapter delivered these vital services without interruption and with scrupulous attention to client and volunteer safety throughout the COVID-19 pandemic, at no cost to those they served, with 90 cents of every dollar donated going directly to mission service delivery; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City Council hereby recognizes March as National Red Cross Month and commemorates the $142^{\rm nd}$ anniversary of the American Red Cross and the $109^{\rm th}$ Anniversary of the Northeast Florida Chapter of the American Red Cross.

Section 2. The Council also commends the volunteers and paid staff of the North Florida Region for their continuing humanitarian service to our City and to the State of Florida.

Section 3. Effective Date. This Resolution shall become

effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
