5 AN ORDINANCE AMENDING SECTION 85.105  
6 (MEMBERSHIP, ORGANIZATION, AND MEETINGS),  
7 CHAPTER 85 (JACKSONVILLE JOURNEY FORWARD),  
8 *ORDINANCE CODE*, TO CLARIFY INITIAL TERMS OF  
9 BOARD MEMBERS; AMENDING SECTION 126.506  
10 (REPORTING), PART 5 (EX-OFFENDER PROGRAM),  
11 CHAPTER 126 (PROCUREMENT CODE), *ORDINANCE CODE*,  
12 TO CLARIFY THE DEADLINE FOR REPORTING BY THE  
13 CHIEF OF PROCUREMENT; PROVIDING FOR CODIFICATION  
14 INSTRUCTIONS; REQUESTING ONE CYCLE EMERGENCY  
15 PASSAGE; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Amending Section 85.105 (Membership,**  
19 **organization, and meetings), Chapter 85 (Jacksonville Journey**  
20 **Forward), Ordinance Code.** Section 85.105 (Membership, organization,  
21 and meetings), Chapter 85 (Jacksonville Journey Forward), *Ordinance*  
22 *Code*, is hereby amended to read as follows:

24 **CHAPTER 85 - JACKSONVILLE JOURNEY FORWARD**

26 **Sec. 85.105. - Membership, organization, and meetings.**

28 (b) *Term of office and appointment.* Members shall serve staggered  
29 four-year terms ending on September 30 or until their qualified  
30 successors have been appointed and confirmed. No member may  
31 serve more than two consecutive full terms. Of the eleven persons  
selected to initially serve on the Board, the three members

1 appointed by the Council President and confirmed by Council  
2 shall serve initial terms of two years, the four members  
3 appointed by the Sheriff of Duval County, the State Attorney of  
4 the Fourth Judicial Circuit, the Superintendent of Duval County  
5 Public Schools, and the Chief Judge for the Fourth Judicial  
6 Circuit, respectively, and confirmed by Council shall serve  
7 initial terms of three years, and the four members appointed by  
8 the Mayor and confirmed by Council shall serve initial terms of  
9 four years. Partial terms shall be governed in accordance with  
10 Chapter 50 of the Code.

12 **Section 2. Amending Section 126.506 (Reporting), Part 5**  
13 **(Ex-Offender Program), Chapter 126 (Procurement Code), Ordinance**  
14 **Code.** Section 126.506 (Reporting), Part 5 (Ex-Offender Program),  
15 Chapter 126 (Procurement Code), *Ordinance Code*, is hereby amended to  
16 read as follows:

17 **CHAPTER 126 - PROCUREMENT CODE**

19 **PART 5. - EX-OFFENDER PROGRAM**

21 **Sec. 126.506. - Reporting.**

22 The Chief shall provide an annual report to the Mayor, the City  
23 Council, and the Jacksonville Journey Forward no later than December  
24 31 of each fiscal year for the previous fiscal year on the information  
25 provided by contractors on the Compliance Report pursuant to this  
26 Section. ~~The first such report shall be due no later than December~~  
27 ~~31, 2018, for the fiscal year beginning October 1, 2017, and ending~~  
28 ~~September 30, 2018.~~ Such annual reports shall at a minimum include  
29 information and data regarding the number of:

31 **Section 3. Codification Instructions.** The Codifier and the

1 Office of General Counsel are authorized to make all chapter and  
2 division "tables of contents" consistent with the changes set forth  
3 herein. Such editorial changes and any others necessary to make the  
4 *Ordinance Code* consistent with the intent of this legislation are  
5 approved and directed herein, and changes to the *Ordinance Code* shall  
6 be made forthwith and when inconsistencies are discovered.

7 **Section 4. Requesting One Cycle Emergency Passage Pursuant**  
8 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
9 legislation is requested. The nature of the emergency is that it is  
10 anticipated the various appointing authorities making appointments  
11 to the Jacksonville Journey Forward board for confirmation by the  
12 City Council will bring those appointments forward in the immediate  
13 future and there is a need to clarify the length of initial terms for  
14 the various seats prior to the appointments being made.

15 **Section 5. Effective Date.** This Ordinance shall become  
16 effective upon signature by the Mayor or upon becoming effective  
17 without the Mayor's signature.
