present advantages, encourage the most appropriate use of land, water and resources, consistent with public interest, overcome present deficiencies, and deal effectively with future problems that may result from the use and development of land within the City of Jacksonville; now, therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Purpose and Intent. This Ordinance is adopted to carry out the purpose and intent of, and exercise the authority set out in, the Local Government Comprehensive Planning and Land Development Regulation Act, Sections 163.3161 through 163.3248, Florida Statutes, and Chapter 166, Florida Statutes, as amended. The amendment modifies the Capital Improvements Element of the 2030 Comprehensive Plan of the City of Jacksonville, to remove the mobility fee calculation from the 2030 Comprehensive Plan and reference the mobility fee calculation in the Ordinance Code.

Section 2. Amendment to Comprehensive Plan. Comprehensive Plan is hereby amended to include the revisions to the text of the Capital Improvements Element from the 2021B Series, which has been initiated by the Planning and Development Department, as more particularly set forth in Exhibit 1, dated May 18, 2021, attached hereto, and incorporated herein by reference.

Effective Date. This Ordinance shall become Section 3. effective upon the signature by the Mayor or upon becoming effective without the Mayor's signature.
