6 (PROHIBITION ON EXPENDITURES FOR ABORTIONS  
7 AND/OR RELATED SERVICES), SUBPART B (SPECIAL  
8 PROVISIONS), PART 3 (APPROPRIATIONS), CHAPTER  
9 106 (BUDGET AND ACCOUNTING CODE), *ORDINANCE*  
10 *CODE*, TO PROHIBIT EXPENDITURE OF CITY FUNDS TO  
11 PAY FOR ABORTIONS AND/OR RELATED SERVICES;  
12 PROVIDING FOR CODIFICATION INSTRUCTIONS;  
13 PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Creating a New Section 106.330.1 (Prohibition on**  
17 **Expenditures For Abortions and/or Related Services), Subpart B**  
18 **(Special Provisions), Part 3 (Appropriations), Chapter 106 (Budget**  
19 **and Accounting Code), Ordinance Code.** A new Section 106.330.1  
20 (Prohibition on Expenditures For Abortions and/or Related Services),  
21 Subpart B (Special Provisions), Part 3 (Appropriations), Chapter 106  
22 (Budget and Accounting Code), *Ordinance Code*, is hereby created to  
23 read as follows:

30 **Sec. 106.330.1. - Prohibition on Expenditures For Abortions and/or**  
31 **Related Services.**

1 The expenditure or use of any City funds to pay for an  
2 "abortion", as that term is defined in Section 390.011, *Florida*  
3 *Statutes*, and/or related services for any person is expressly  
4 prohibited.

5 **Section 2. Codification Instructions.** The Codifier and the  
6 Office of General Counsel are authorized to make all chapter and  
7 division "table of contents" consistent with the changes set forth  
8 herein. Such editorial changes and any other changes necessary to  
9 make the *Ordinance Code* consistent with the intent of this legislation  
10 are approved and directed herein, and the changes to the *Ordinance*  
11 *Code* shall be made forthwith and when inconsistencies are discovered.

12 **Section 3. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
