6 A RESOLUTION SUPPORTING HOUSE BILL 0385
7 DESIGNATING A PORTION OF U.S. ROUTE 90 BETWEEN
8 YELLOW WATER ROAD AND LOG ROAD IN DUVAL COUNTY
9 AS "TROOPER ROBERT P. MCDERMON MEMORIAL
10 HIGHWAY"; DIRECTING THE CHIEF OF LEGISLATIVE
11 SERVICES TO SEND A COPY OF THIS RESOLUTION TO
12 THE FLORIDA DEPARTMENT OF TRANSPORTATION,
13 DUVAL LEGISLATIVE DELEGATION, THE FLORIDA
14 SENATE PRESIDENT AND THE SPEAKER OF THE
15 FLORIDA HOUSE; PROVIDING AN EFFECTIVE DATE.

17 **WHEREAS**, during the 2019 Legislative Session, the Florida
18 Legislature passed House Bill 0385, which makes honorary
19 designations of transportation facilities throughout Florida and
20 directs the Florida Department of Transportation (FDOT) to erect
21 suitable markers for those designations; and

22 **WHEREAS**, House Bill 0385 designates that portion of U.S. Route
23 90 (72010000) between Yellow Water Road and Log Road in Duval
24 County as "Trooper Robert P. McDermon Memorial Highway"; and

25 **WHEREAS**, Section 334.071, Florida Statutes, provides that a
26 city or county must pass a resolution in support of a particular
27 designation before road markers are erected; and

28 **WHEREAS**, the City of Jacksonville wishes to honor Trooper
29 Robert P. McDermon and requests that the Florida Department of
30 Transportation erect suitable markers designating a portion of U.S.

1 Route 90 (72010000) between Yellow Water Road and Log Road in Duval
2 County as "Trooper Robert P. McDermon Memorial Highway"; now
3 therefore

4 **BE IT RESOLVED** by the Council of the City of Jacksonville:

5 **Section 1.** The City of Jacksonville strongly supports
6 House Bill 0385, and designation of a portion of U.S. Route 90
7 (72010000) between Yellow Water Road and Log Road in Duval County
8 as the "Trooper Robert P. McDermon Memorial Highway," and hereby
9 authorizes the erection of appropriate signage by the Florida
10 Department of Transportation to commemorate the designation.

11 **Section 2. Direction to Chief of Legislative Services.**

12 The Chief of Legislative Services for the City Council is hereby
13 directed to provide a copy of this Resolution to the Florida
14 Department of Transportation, Duval County Legislative Delegation,
15 Florida Senate President and Speaker of the Florida House.

16 **Section 3. Effective Date.** This Resolution shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
