5 AN ORDINANCE AMENDING SECTION 154.107 (SALE AND  
6 CONSUMPTION OF ALCOHOLIC BEVERAGES IN MUNICIPAL  
7 PARKS OR ON CITY-OWNED OR -LEASED PROPERTY;  
8 PENALTY), *ORDINANCE CODE*, TO ADD AIRPORTS TO THE  
9 LIST OF LOCATIONS THAT ALLOW ALCOHOLIC BEVERAGES  
10 TO BE SOLD, SERVED AND CONSUMED AT ANY TIME;  
11 PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Amending Section 154.107 (Sale and consumption**  
15 **of alcoholic beverages in municipal parks or on City-owned or -leased**  
16 **property; penalty), *Ordinance Code*.** Section 154.107 (Sale and  
17 consumption of alcoholic beverages in municipal parks or on City-  
18 owned or -leased property; penalty), *Ordinance Code*, is hereby amended  
19 to read as follows:

20 **CHAPTER 154. ALCOHOLIC BEVERAGES**

21 **PART 1. IN GENERAL**

23 **Sec. 154.107. Sale and consumption of alcoholic beverages in**  
24 **municipal parks, ~~or~~ on City-owned or -leased property, or airports;**  
25 **penalty.**

27 (j) Alcoholic beverages, which have been purchased or served under  
28 the authority of any alcohol license issued to the  
29 Jacksonville Aviation Authority pursuant to F.S. § 561.17, may  
30 be sold, served and consumed at any time at the Jacksonville  
31 International Airport located at 2400 Yankee Clipper Drive and

1 as otherwise consistent with State of Florida law and City  
2 Municipal Code requirements. Jacksonville Aviation Authority  
3 owns and operates Jacksonville International Airport pursuant  
4 to Chapter 2001-319 Laws of Florida.

5 ~~(j)~~(k) Nothing contained in this Section is intended to encourage,  
6 promote or otherwise sanction or provide a defense for conduct  
7 that is unlawful under federal, State or local law including,  
8 but not limited to, disorderly intoxication, driving under the  
9 influence of alcohol, or possession of illegal substances.

10 ~~(k)~~ (l) Nothing contained in this Section is intended to limit the  
11 lawful discretionary authority of the Jacksonville Sheriff's  
12 Office, the Jacksonville Aviation Authority police or federal or  
13 state law enforcement agencies to enforce or not enforce the  
14 provisions herein as permitted by statute, case law or other  
15 legal enactment.

16 ~~(l)~~ (m) Nothing contained in this Section is intended to affect the  
17 prosecution of selective enforcement claims under the federal or  
18 State constitutions based on race, gender, ethnicity or other  
19 suspect categories as such claims are currently defined under  
20 well-established case law.

21 **Section 2. Effective Date.** This ordinance shall become  
22 effective upon signature by the Mayor or upon becoming effective  
23 without the Mayor's signature.
