The fees 14 contained within this Section are subject to the Annual Review of 15 Fees provision found in Section 106.112, Ordinance Code.

16 Section 2. Codification Instructions. The Codifier and the 17 Office of General Counsel are authorized to make all chapter and 18 division "tables of contents" consistent with the changes set forth 19 herein. Such editorial changes and any others necessary to make the 20 Ordinance Code consistent with the intent of this legislation are 21 approved and directed herein, and changes to the Ordinance Code shall 22 be made forthwith and when inconsistencies are discovered.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
