7 FOR BEING NAMED A MONTHLY WINNER OF THE 2025
8 NATIONAL LIFE GROUP DO GOOD HEROES AWARD IN
9 RECOGNITION OF HIS EXEMPLARY COMMUNITY SERVICE;

12 **WHEREAS**, Lieutenant Travis J. Cox, of the Jacksonville Sheriff's
13 Office, has been selected as monthly winner of the 2025 National Life
14 Group Do Good Heroes Award, recognizing his outstanding contributions
15 to community service in Jacksonville; and

16 **WHEREAS**, the Do Good Heroes Award honors fire rescue and police
17 personnel who go above and beyond their public safety duties in
18 service to the community, Lt. Cox was nominated by Belline Bonaparte
19 of Gravity Financial in recognition of his leadership and dedication
20 to making a positive impact; and

21 **WHEREAS**, Lt. Cox is a 2021 graduate of Leadership Jacksonville
22 and serves as an active board member of the MaliVai Washington Youth
23 Foundation, supporting youth development and education throughout our
24 community; and

25 **WHEREAS**, Lt. Cox organized a lifesaving active shooter training
26 drill for local schools and delivered safety improvement strategies
27 in places of worship at a Sunday School Publishing Board Conference;

29 **WHEREAS**, as part of this recognition, Lt. Cox was honored at a
30 celebration on Saturday, August 16, 2025 at the Sawgrass Marriott
31 Ponte Vedra Beach, and will receive a \$500 award to donate to a
