AN ORDINANCE APPROPRIATING \$892,698.32 FROM THE GENERAL FUND OPERATING RESERVES TO SUBSIDIES & CONTRIBUTIONS TO PRIVATE ORGANIZATIONS TO PROVIDE THE BALANCE OF THE AIRLINE NETWORK GRANT TO BREEZE AVIATION GROUP, INC. ("COMPANY"), CONSISTENT WITH THE ECONOMIC DEVELOPMENT AGREEMENT PREVIOUSLY APPROVED BY ORDINANCE 2022-318-E, AS INITIATED BY B.T. 25-033; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville ("City") and Breeze Aviation, Group, Inc. ("Company") previously entered into that certain Economic Development Agreement dated July 29, 2022 (as amended, the "EDA"), as authorized by Ordinance 2022-318-E, pursuant to which the City granted the Company an Airline Network Grant ("Grant") in the up-to amount of \$1,000,000; and

WHEREAS, the \$1,000,000 of Grant funds was appropriated in Ordinance 2022-317-E, however those funds lapsed effective October 1, 2024, even though the EDA authorizes disbursements for eligible expenditures through January 29, 2025; and

WHEREAS, OED is requesting the appropriation of the balance of the Grant funds to provide the remaining portion of the Grant for which the Company is eligible, consistent with the terms and conditions of the EDA; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there are hereby appropriated the indicated
