4 **ORDINANCE 2021-82**

5 AN ORDINANCE APPROPRIATING \$36,000.00 FROM THE
6 SOCIAL JUSTICE AND COMMUNITY INVESTMENT SPECIAL
7 COMMITTEE CONTINGENCY TO PROVIDE FUNDING TO CITY
8 COUNCIL FOR THE "SAFER TOGETHER" SERIES OF
9 WORKSHOPS FOR FACILITATION (\$23,500), TRAVEL AND
10 HONORARIUM (\$10,000), AND MISCELLANEOUS
11 EXPENSES (\$2,500); APPROVING, AND AUTHORIZING
12 THE CITY COUNCIL TO EXECUTE AND DELIVER AN
13 AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND
14 ALL THINGS DIVERSE, LLC, FOR SERVICES RENDERED
15 ON BEHALF OF THE "SAFER TOGETHER" SERIES OF
16 WORKSHOPS; PROVIDING FOR OVERSIGHT BY THE
17 COUNCIL SECRETARY; PROVIDING FOR REVERTER OF
18 FUNDS; REQUESTING ONE CYCLE EMERGENCY PASSAGE;
19 PROVIDING AN EFFECTIVE DATE.

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
23 within the City's budget, there are hereby appropriated the indicated
24 sum(s) from the account(s) listed in subsection (a) to the account(s)
25 listed in subsection (b):

1 (c) **Explanation of Appropriation** - The funding above is being
2 appropriated from the Social Justice and Community
3 Investment Special Committee Contingency to City Council
4 to provide funding for the "Safer Together" Series of
5 Workshops.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to provide funding to City Council in the amount of
8 \$36,000.00 for the "Safer Together" Series of Workshops for
9 facilitation (\$23,500), travel and honorarium (\$10,000), and
10 miscellaneous expenses (\$2,500), as more fully described in **Exhibit**
11 **2** attached hereto.

12 **Section 3. Approval and authorization to execute Service**
13 **Contract.** The City Council is hereby authorized to execute an
14 agreement with All Things Diverse, LLC for compensation for services
15 rendered to the "Safer Together" Series of Workshops. A copy of the
16 agreement with scope of services is attached hereto as **Exhibit 3.**

17 **Section 4. Invoking the exception to Section 126.107(g),**
18 **Ordinance Code.** The City is hereby authorized to directly procure
19 the use of the professional services of All Things Diverse, LLC, to
20 provide services as more particularly described in Section 2. Pursuant
21 to Section 126.107(g) (Exemptions), Part 1 (General Regulations),
22 Chapter 126 (Procurement Code), *Ordinance Code*, such procurement is
23 exempted from competitive solicitation because the supplies or
24 services are to be provided by those specifically prescribed within
25 authorizing legislation that appropriates the same. With the
26 exception of the foregoing, all other provisions of Chapter 126,
27 *Ordinance Code*, shall remain in full force and effect.

28 **Section 5. Oversight.** The Council Secretary will oversee
29 the Agreement described in Section 3 above and to ensure compliance
30 with all other appropriate laws.

1 **Section 6. Reverter.** Any unused funds shall revert to the
2 account of origin.

3 **Section 7. Requesting One Cycle Emergency Passage Pursuant**
4 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
5 legislation is requested. The nature of the emergency is that the
6 "Safer Together" Series of Workshops have commenced and the workshops
7 need to be completed by June 30, 2021.

8 **Section 8. Effective Date.** This ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
