BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Lease agreement approved and execution authorized. There is hereby approved, and the Mayor, designee, and Corporation Secretary are hereby authorized execute and deliver, that certain Lease Agreement between Northwest Jacksonville Community Development Corporation, Inc. ("Landlord") and the City of Jacksonville ("Tenant"), and that Assignment between the City of Jacksonville as Assignor and the Florida Department of Health as Assignee, all in substantially the same form as Revised On File with the Division of Legislative lease with Northwest Services. The Jacksonville Community Development Corporation, Inc. is for use by the Duval County Health Department as a dental clinic and located at 3416 Moncrief Road, Suite 100, Jacksonville, Duval County, Florida 32209, for a term of five (5) years at a monthly basic rental rate of \$1,200.00. The lease responsibilities, including the responsibility to pay rent, will be performed by Assignee.

Section 2. Requesting one cycle emergency passage pursuant to Council Rule 4.901 Emergency. One cycle emergency passage of this legislation is requested. The nature of the emergency is that current lease expired on March 25, 2020, and so it is in the interest of the continued public health of the City's citizens for the Council to expedite this legislation to allow for execution of the new lease as soon as possible.

Section 3. Effective Date. This ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
