4 **ORDINANCE 2023-443-E**

5 AN ORDINANCE APPROVING, AND AUTHORIZING AN
6 EXPENDITURE FROM THE PARKS, RECREATION AND
7 COMMUNITY SERVICES TRUST FUND IN THE AMOUNT OF
8 \$500,000 IN ACCORDANCE WITH SECTION 111.105(b),
9 *ORDINANCE CODE*, TO BE USED TO CONSTRUCT AND
10 INSTALL WALKING TRAILS AND LIGHTING AT THE FORT
11 FAMILY REGIONAL PARK AT BAYMEADOWS; PROVIDING AN
12 EFFECTIVE DATE.

14 **WHEREAS**, in 2018, as authorized by Ordinance 2018-89-E, the City
15 entered into an agreement with Perimeter Realty, Inc. ("Perimeter")
16 pursuant to which Perimeter would contribute a total of \$1,000,000
17 to the City over a ten-year period (\$100,000 annually) for
18 maintenance, improvements and enhancements to a park then known as
19 "9A/Baymeadows Regional Park" in exchange for naming rights to the
20 park which then became known as the "Fort Family Regional Park at
21 Baymeadows"; and

22 **WHEREAS**, Perimeter has made annual contributions to the City in
23 accordance with the agreement, with said funds being deposited in the
24 Parks, Recreation, and Community Services Trust Fund established in
25 Section 111.105(b), *Ordinance Code*, (the "PRCS Trust Fund"); and

26 **WHEREAS**, the Parks, Recreation and Community Services Department
27 desires to expend funds from the PRCS Trust Fund in an amount not-
28 to-exceed \$500,000 to construct and install certain improvements to
29 the Fort Family Regional Park at Baymeadows; and

30 **WHEREAS**, Section 111.105(b), *Ordinance Code*, states that any
31 expenditure from the PRCS Trust Fund in excess of \$100,000 shall

1 require City Council approval; now, therefore

2 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 1.** The City Council hereby approves, and authorizes
4 the Parks, Recreation and Community Services Department Director to
5 expend funds from the PRCS Trust Fund in an amount not-to-exceed
6 \$500,000 for construction and installation of walking trails and
7 lighting at Fort Family Regional Park at Baymeadows, in accordance
8 with Section 111.105(b), *Ordinance Code*.

9 **Section 2. Effective Date.** This Ordinance shall
10 become effective upon signature by the Mayor or upon becoming
11 effective without the Mayor's signature.
