16 **Section 1. Appropriation.** For the 2023-2024 fiscal year,

31 Section 1 above is to provide funding for cybersecurity strengthening

2 **Section 3. Carryover.** The funds appropriated in this  
3 Ordinance shall not lapse but shall carryover to fiscal year 2024-  
4 2025.

5 **Section 4. Oversight.** The Technology Solutions  
6 Department shall oversee the project described herein.

7 **Section 5. Requesting One-Cycle Emergency Passage Pursuant**  
8 **to Council Rule 4.901 Emergency.** One-cycle passage of this  
9 legislation is requested. The nature of the emergency is to ensure  
10 expeditious implementation of cybersecurity strengthening.

11 **Section 6. Effective Date.** This Ordinance shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
