9 AN ORDINANCE CREATING A NEW SECTION 111.275  
10 (JACKSONVILLE VETERANS AND MILITARY FAMILY  
11 COMMUNITY CENTER AND FACILITIES SPECIAL REVENUE  
12 FUND), PART 2 (HEALTH AND HUMAN SERVICES),  
13 CHAPTER 111 (SPECIAL REVENUE AND TRUST  
14 ACCOUNTS), *ORDINANCE CODE*, TO ESTABLISH A  
15 JACKSONVILLE VETERANS AND MILITARY FAMILY  
16 COMMUNITY CENTER AND FACILITIES SPECIAL REVENUE  
17 FUND FOR THE PURPOSES DESCRIBED HEREIN;  
18 PROVIDING FOR CODIFICATION INSTRUCTIONS;

21 **BE IT ORDAINED** by the Council of the City of Jacksonville:

22 **Section 1. Creating a new Section 111.275 (Jacksonville**  
23 **Veterans and Military Family Community Center and Facilities Special**  
24 **Revenue Fund), Part 2 (Health and Human Services), Chapter 111**  
25 **(Special Revenue and Trust Accounts), *Ordinance Code*.** A new Section  
26 111.275 (Jacksonville Veterans and Military Family Community Center  
27 and Facilities Special Revenue Fund), Part 2 (Health and Human  
28 Services), Chapter 111 (Special Revenue and Trust Accounts),  
29 *Ordinance Code*, is hereby created to read as follows:

30 **CHAPTER 111. SPECIAL REVENUE AND TRUST ACCOUNTS**

**PART 2. HEALTH AND HUMAN SERVICES****\* \* \*****Sec. 111.275. - Jacksonville Veterans and Military Family Community Center and Facilities Special Revenue Fund.**

There is hereby created the Jacksonville Veterans and Military Family Community Center and Facilities Special Revenue Fund (the "Fund"), a permanent special revenue fund of the City, into which shall be deposited all donations, gifts, grants, fees, transfers and funds as may be from time to time received by the City for the purpose of designing, planning, constructing, maintaining, operating, staffing and equipping a Jacksonville Veterans and Military Family Community Center and other similar veterans facilities. The sums placed into the Fund, together with any interest accrued thereon, are hereby appropriated for purposes described in this Section, and such appropriations shall not lapse at the close of any fiscal year but shall carry over to the next fiscal year. The Director of the Finance Department is authorized and directed to make disbursements from the Fund upon the written request of the Director of the Military Affairs and Veterans Department, subject to availability of funds from the Fund, however, any single expenditure from this Fund in excess of \$100,000 shall require prior Council approval. No later than June 30 annually, the Director of the Military Affairs and Veterans Department shall provide a report of receipts and disbursements to the City Council.

**Section 2. Codification Instructions.** The Codifier and the Office of General Counsel are authorized to make all chapter and division "table of contents" consistent with the changes set forth herein, including renumbering of sections. Such editorial changes and any other changes necessary to make the *Ordinance Code* consistent with the intent of this legislation are approved and directed herein, and the changes to the *Ordinance Code* shall be made forthwith and

when inconsistencies are discovered.

**Section 3. Effective Date.** This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
