5 AN ORDINANCE APPROVING THE COLLECTIVE  
6 BARGAINING AGREEMENT BETWEEN JEA AND  
7 NORTHEAST FLORIDA PUBLIC EMPLOYEES' LOCAL 630  
8 LABORERS' INTERNATIONAL UNION OF NORTH  
9 AMERICA, AFL-CIO ("LIUNA"), SUCH AGREEMENT  
10 COMMENCING OCTOBER 1, 2019 AND ENDING  
11 SEPTEMBER 30, 2022; PROVIDING AN EFFECTIVE  
12 DATE.

14 **WHEREAS**, on September 24, 2019, the JEA Board met and  
15 reviewed the agenda item regarding the Collective Bargaining  
16 Agreement between JEA and the Northeast Florida Public Employees'  
17 Local 630 Laborers' International Union of North America, AFL-CIO  
18 ("LIUNA"), a copy of the agenda item is attached hereto as **Exhibit**  
19 **1**; and

20 **WHEREAS**, the JEA Board has authorized the JEA Chief Executive  
21 Officer to approve the Collective Bargaining Agreement between JEA  
22 and the Northeast Florida Public Employees' Local 630 Laborers'  
23 International Union of North America, AFL-CIO ("LIUNA"); and

24 **WHEREAS**, on September 19, 2019, the Northeast Florida Public  
25 Employees' Local 630 Laborers' International Union of North  
26 America, AFL-CIO ("LIUNA") ratified the Collective Bargaining  
27 Agreement between JEA and the Northeast Florida Public Employees'  
28 Local 630 Laborers' International Union of North America, AFL-CIO  
29 ("LIUNA"); and

30 **WHEREAS**, JEA has requested that the City Council approve the  
31 Collective Bargaining Agreement; now therefore

1           **BE IT ORDAINED** by the Council of the City of Jacksonville:

2           **Section 1.           JEA and Northeast Florida Public Employees'**  
3 **Local 630 Laborers' International Union of North America, AFL-CIO**  
4 **("LIUNA") Agreement Approved.** That certain Collective Bargaining  
5 Agreement Between JEA and the Northeast Florida Public Employees'  
6 Local 630 Laborers' International Union of North America, AFL-CIO  
7 ("LIUNA"), a copy of which is **On File** with the Legislative Services  
8 Division, and by this reference is made a part hereof, is hereby  
9 approved. Said Collective Bargaining Agreement is for a term  
10 commencing October 1, 2019 and ending September 30, 2022.

11           **Section 2.           Effective Date.** This ordinance shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
