5 AN ORDINANCE APPROPRIATING \$500,000.00 FROM
6 THE DISABLED PARKING FINES SPECIAL REVENUE
7 FUND RPDS1H8 TO COVER IMPROVEMENTS IN
8 ACCESSIBILITY, AWARENESS, AND QUALITY OF LIFE
9 FOR PEOPLE WITH DISABILITIES, AS INITIATED BY
10 B.T. 19-115; PROVIDING FOR A CARRYOVER OF
11 FUNDS INTO SUBSEQUENT FISCAL YEARS; PROVIDING
12 AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1.** For the 2018-2019 fiscal year, within the City's
16 budget, there are hereby appropriated the indicated sum(s) from the
17 account(s) listed in subsection (a) to the account(s) listed in
18 subsection (b):

25 (c) Explanation of Appropriation

26 The funding above is an appropriation of parking fines
27 from the Disabled Parking Fines Special Revenue Fund
28 RPDS1H8 35402 to RPDS1H8 04211, 04221, and 04904 to cover
29 improvements in accessibility, awareness, and quality of
30 life for people with disabilities.

1 **Section 2. Carryover.** The funds appropriated by this
2 ordinance shall not lapse but shall carry over to subsequent fiscal
3 years.

4 **Section 3. Purpose.** The purpose of the appropriation in
5 Section 1 is to provide funds for adaptive recreation, student
6 scholarships, summer camp sponsorships, the Mayor's Disability
7 Council initiatives, the emergency assistance program, the
8 wheelchair ramp program, educational symposiums, and the
9 remediation of inaccessible electronic files to ensure online
10 accessibility.

11 **Section 4. Effective Date.** This ordinance shall become
12 effective upon signature by the Mayor or upon becoming effective
13 without the Mayor's signature.
