7 AN ORDINANCE APPROPRIATING \$1,880,120.00 FROM
8 THE GENERAL FUND - GSD FUND BALANCE INTO THE
9 KIDS HOPE ALLIANCE SUBFUND TO FUND PROGRAMS
10 AND SERVICES FOR AT-HOPE CHILDREN AND YOUTH IN
11 JACKSONVILLE, AS INITIATED BY B.T. 20-064;
12 INVOKING THE EXCEPTION OF SECTION 126.107(G)
13 (EXEMPTIONS), PART 1 (GENERAL REGULATIONS),
14 CHAPTER 126 (PROCUREMENT CODE), *ORDINANCE*
15 *CODE*, REGARDING CHILDREN'S SERVICES PROGRAM
16 CONTRACTS TO BE PROVIDED BY PROVIDERS
17 SPECIFIED IN THIS ORDINANCE; AUTHORIZING THE
18 MAYOR, OR HIS DESIGNEE, AND CORPORATION
19 SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER
20 OF THE KIDS HOPE ALLIANCE TO EXECUTE AND
21 DELIVER CHILDREN'S SERVICES CONTRACTS WITH
22 PROVIDERS SPECIFIED IN THIS ORDINANCE; WAIVING
23 THE REQUIREMENTS OF SECTION 77.111(a)
24 (PROVIDER CONTRACTS), CHAPTER 77 (KIDS HOPE
25 ALLIANCE), *ORDINANCE CODE*, TO EXEMPT
26 CHILDREN'S SERVICES PROGRAMMING TO BE PROVIDED
27 BY PROVIDERS SPECIFIED IN THIS ORDINANCE FROM
28 COMPETITIVE PROCUREMENT; PROVIDING AN
29 EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2019-2020 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(B.T. 20-064 attached hereto as **Exhibit 1** and incorporated herein by this reference)

(c) Explanation of appropriation

The funding above is an appropriation of \$1,880,120 from the general fund - gsd fund balance into the Kids Hope Alliance subfund.

Section 2. Purpose. The purpose of the appropriation in this ordinance is to fund programs and services for at-hope children and youth in Jacksonville, as listed on the First Revised 2019-511-E Schedule M, a copy of which is attached hereto as **Exhibit 2.** The following funds will be made available to be awarded to providers under Chapter 126, *Ordinance Code*: (i) \$577,664 will be made available under KHA's ESC-0210-20 for Juvenile Justice Prevention & Intervention Programs; (ii) \$421,389 will be made available under KHA's ESC-0218-20 for Special Needs Programs and Services; and (iii) \$402,308 will be made available under KHA's ESC-0212-20 for Preteen and Teen Programs. In addition, \$478,759 will fund the providers listed in **Exhibit 3** for the programs shown in **Exhibit 3.**

Section 3. Invoking the exception to Section 126.107(g), Ordinance Code. The Kids Hope Alliance is hereby authorized to procure children's services from the providers listed and in the

1 contract amounts shown in **Exhibit 3**, attached hereto and
2 incorporated herein by this reference. Pursuant to Section
3 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126
4 (Procurement Code), *Ordinance Code*, such services are exempted from
5 competitive solicitation because the children's services to be
6 provided by the specified providers are being appropriated and
7 approved in this authorizing legislation.

8 **Section 4. Approval and authorization to execute.** The
9 Mayor, or his designee, the Corporation Secretary, and/or the Chief
10 Executive Officer of the Kids Hope Alliance ("CEO") are hereby
11 authorized to execute contracts with the children's services
12 providers listed in **Exhibit 3** for the children's services programs
13 shown in **Exhibit 3** and appropriated and authorized in Sections 1
14 and 3 above.

15 **Section 5. Waiver of the provisions in Chapter 77 (Kids**
16 **Hope Alliance), Section 77.111(a) (Provider Contracts).** The City
17 hereby waives the provisions in Chapter 77 (Kids Hope Alliance),
18 Section 77.111(a) (Provider Contracts) with respect to the contracts
19 approved and authorized under Section 3 of this Ordinance. Section
20 77.111(a) requires contracts for children's services to be
21 competitively procured by KHA via an evaluated bid process. The
22 waiver is needed in order to allow the Kids Hope Alliance to
23 expeditiously provide these children's services without the delay
24 involved in a competitive procurement.

25 **Section 6. Effective Date.** This ordinance shall become
26 effective upon signature by the Mayor or upon becoming effective
27 without the Mayor's signature.
