9 PURCHASE FOOD AND BEVERAGE FOR SPECIAL EVENTS
10 AND ACTIVITIES FOR LEADERSHIP TRAINING AND
11 RECRUITMENT OF NEW CITIZENS PLANNING ADVISORY
12 COMMITTEE ("CPAC") MEMBERS, AS INITIATED BY B.T.
13 23-083; AMENDING ORDINANCE 2022-504-E, THE
14 FISCAL YEAR 2022-2023 BUDGET, BY AMENDING THE
15 REVISED ATTACHMENT A TO AUTHORIZE EXPENDITURE OF
16 THESE FUNDS ON FOOD AND BEVERAGE FOR SPECIAL
17 EVENTS AND ACTIVITIES; PROVIDING FOR AN
18 EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
22 within the City's budget, there is hereby appropriated the indicated
23 sum from the account(s) listed in subsection (a) to the account(s)
24 listed in subsection (b):

31 (c) Explanation of Appropriation:

1 The funding above is an appropriation of \$5,500.00 from
2 the Neighborhoods Department Fight Blight Awareness
3 Campaign Advertising and Promotion Account to purchase food
4 and beverage for various special events and activities for
5 leadership training and recruitment of new Citizens
6 Planning Advisory Committee ("CPAC") members.

7 **Section 2. Purpose.** The purpose of the appropriation in
8 Section 1 is to transfer funds from the Neighborhoods Department
9 Fight Blight Awareness Campaign to purchase food and beverage for
10 certain special events and activities hosted by the Neighborhood
11 Services Office. A majority of these events are held on an annual
12 basis for leadership training and CPAC membership recruitment. These
13 events include, but are not limited to, CommUniverCity, community
14 leadership programs, and the Neighborhood Awards Program which, this
15 year, will be combined with the 30th Anniversary celebration of CPACs.

16 **Section 3. Amending Ordinance 2022-504-E, the Fiscal Year**
17 **2022-2023 Budget, to Amend Revised Attachment A.** Ordinance 2022-504-
18 E, adopting the 2022-2023 fiscal year budget, is hereby amended to
19 replace the Revised Attachment A, entitled "Food and Beverage
20 Expenditures", to authorize expenditure of these funds for the
21 purchase of food and beverage for the purposes outlined above. The
22 Second Revised Attachment A is attached hereto as **Exhibit 2** and
23 incorporated herein by this reference.

24 **Section 4. Effective Date.** This Ordinance shall become
25 effective upon signature by the Mayor or upon becoming effective
26 without the Mayor's signature.
