8 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT,
9 ORIGINALLY APPROPRIATED BY ORDINANCE 2020-258-
10 E, TO PROVIDE FUNDING FOR DOWN PAYMENT
11 ASSISTANCE AND REHABILITATION OF AFFORDABLE
12 HOUSING FOR RENT OR OWNERSHIP BY LOW- AND
13 MODERATE-INCOME INDIVIDUALS AND FAMILIES, AS
14 INITIATED BY B.T. 21-024; PROVIDING AN
15 EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
19 within the City's budget, there is hereby appropriated the
20 indicated sum(s) from the account(s) listed in subsection (a) to
21 the account(s) listed in subsection (b):

28 (c) Explanation of Appropriation:

29 The funding above is a re-appropriation of existing funds
30 received by the City from the U.S. Department of Housing
31 and Urban Development ("HUD") for the annual federal HOME

1 Investment Partnership (HOME) Grant Program originally
2 appropriated by Ordinance 2020-258-E (the "Appropriation
3 Ordinance") for fiscal year 2020-2021.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to re-allocate HOME Grant Program funds originally
6 appropriated by Ordinance 2020-258-E to provide funding for down
7 payment assistance and rehabilitation of affordable housing for
8 rent or ownership by low- and moderate-income individuals and
9 families and to correct certain revenue and project information
10 provided on BT21-003 as approved by Ordinance 2020-258-E. This re-
11 allocation is necessary to adjust for the Governor's veto of
12 affordable housing funding in the State of Florida fiscal year
13 2020-2021 budget and will allow these programs to remain open for a
14 portion of the 2020-2021 fiscal year instead of remaining closed.
15 In addition, HUD has approved, via an administrative waiver, the
16 City's use of up to twenty-five percent (25%) of these funds to pay
17 for the City's administration of the HOME Grant Program.

18 **Section 3. Effective Date.** This ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
