## **ORDINANCE 2024-938**

AN ORDINANCE APPROPRIATING \$30,000 FROM A CONTINGENCY ACCOUNT WITHIN THE KIDS HOPE ALLIANCE ("KHA") FUND TO THE SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT TO PROVIDE FUNDING TO JACKSONVILLE ARTS AND MUSIC SCHOOL INC. ("JAMS") FOR THE ARTWORKS INITIATIVE (THE "PROGRAM") AS DESCRIBED HEREIN; INVOKING THE EXEMPTION IN SECTION 126.108(G) (EXEMPTIONS FROM COMPETITIVE SOLICITATION), PART 1 (GENERAL REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC CONTRACTING), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH JAMS FOR THE PROGRAM; WAIVING THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY JAMS FROM COMPETITIVE PROCUREMENT; WAIVING THE AGE REQUIREMENTS OF SECTION 77.105(E) (DEFINITIONS), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO ALLOW JAMS TO PROVIDE SERVICES THROUGH THE PROGRAM TO HIGH SCHOOL AND COLLEGE STUDENTS THROUGH AGE 24; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE OR KHA AND JACKSONVILLE ARTS AND MUSIC SCHOOL INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.
