5 AN ORDINANCE APPROPRIATING \$143,617.00 IN GRANT
6 FUNDING FROM THE CHARTRAND FAMILY FUND FOR THE
7 PEACE OFFICER WELLNESS EMPATHY AND RESILIENCE
8 ("POWER") PROGRAM, AS INITIATED BY B.T. 25-057;
9 PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE
10 SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.

12 **BE IT ORDAINED** by the Council of the City of Jacksonville:

13 **Section 1. Appropriation.** For the 2024-2025 fiscal year,
14 within the City's budget, there is hereby appropriated the indicated
15 sum(s) from the account(s) listed in subsection (a) to the account(s)
16 listed in subsection (b):

23 (c) Explanation of Appropriation:
24 The funding above represents an appropriation of grant
25 funds from the Chartrand Family Fund for year 2 of the
26 Peace Officer Wellness Empathy and Resilience ("POWER")
27 Program. The grant period commenced on January 1, 2024,
28 and continues through December 31, 2029. No local match is
29 required.

30 **Section 2. Purpose.** The purpose of the appropriation in
31 Section 1 is to utilize grant funding from the Chartrand Family Fund

1 to supplement a five-year implementation of the POWER Training Program
2 intended to train 450 to 500 diverse officers on stress, resiliency,
3 performance and community building in order to enhance performance,
4 improve situational awareness, increase physical health and cognitive
5 performance and develop new leadership capacity, which will improve
6 capacity for positive relations with fellow officers and the
7 community. A copy of the Grant Proposal outlining the terms and
8 conditions related to the grant and use of the grant funds as well
9 as the program budget for year 2 of the program have been placed **On**
10 **File** with the Legislative Services Division and are incorporated
11 herein by this reference.

12 **Section 3. Oversight.** The Jacksonville Sheriff's Office
13 shall oversee administration of the grant and project described
14 herein.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
