6 JACKSONVILLE SMALL AND EMERGING BUSINESSES  
7 ("JSEB") ACCESS TO CAPITAL PROGRAM DOLLARS,  
8 INCLUDING \$215,474.00 IN UNAPPROPRIATED  
9 INDUSTRY DEVELOPMENT SUBFUND FUND BALANCE AND  
10 \$675,693.56 FROM THE OFFICE OF ECONOMIC  
11 DEVELOPMENT SPECIAL INITIATIVES - INDUSTRY  
12 DEVELOPMENT ACTIVITY OTHER PROFESSIONAL  
13 SERVICES ACCOUNT AND LOANS ACCOUNT TO THE EQUAL  
14 BUSINESS OPPORTUNITY OFFICE (THE "EBO OFFICE")  
15 OTHER PROFESSIONAL SERVICES ACCOUNT AND LOAN  
16 ACCOUNT FOR ADMINISTRATION OF THE JSEB ACCESS TO  
17 CAPITAL PROGRAM BY THE EBO OFFICE, AS INITIATED  
18 BY B.T. 23-008; PROVIDING AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
22 within the City's budget, there are hereby appropriated the indicated  
23 sum(s) from the account(s) listed in subsection (a) to the account(s)  
24 listed in subsection (b):

31 (c) **Explanation of Appropriation:**

1 The funding above represents an appropriation of  
2 \$891,167.56 to the Equal Business Opportunity Office (the  
3 "EBO Office") Other Professional Services account  
4 (\$19,930.00) and Loans account (\$871,237.56) for  
5 administration of the Jacksonville Small and Emerging  
6 Businesses ("JSEB") Access to Capital Program. Funds  
7 appropriated hereby include unappropriated fund balance in  
8 the amount of \$215,474.00 from the JSEB Access to Capital  
9 Program Industry Development subfund and \$675,693.56 from  
10 the Office of Economic Development Special Initiatives -  
11 Industry Development activity (including \$19,930.00 from  
12 the Other Professional Services account and \$655,763.56  
13 from the Loans account).

14 **Section 2. Purpose.** The purpose of the appropriation in  
15 Section 1 is to reallocate funding from the Office of Economic  
16 Development to the EBO Office for administration of the JSEB Access  
17 to Capital Program. The Office of Economic Development was previously  
18 responsible for administration of the JSEB Access to Capital Program.  
19 This responsibility has since shifted to the EBO Office in accordance  
20 with changes to the City's *Ordinance Code* effectuated by Ordinance  
21 2021-117-E.

22 **Section 3. Effective Date.** This Ordinance shall become  
23 effective upon signature by the Mayor or upon becoming effective  
24 without the Mayor's signature.
