ORDINANCE 2021-788-E

AN ORDINANCE AMENDING FISCAL YEAR 2018-2019 JACKSONVILLE TRANSPORTATION AUTHORITY (JTA) BUDGET; AMENDING ORDINANCE 2018-504-E (THE CITY OF JACKSONVILLE BUDGET ORDINANCE) BY AMENDING THE JTA BUDGET REVISED SCHEDULES O AND P; AN ORDINANCE AMENDING FISCAL YEAR 2019-2020 TRANSPORTATION AUTHORITY JACKSONVILLE BUDGET; AMENDING ORDINANCE 2019-504-E (THE CITY OF JACKSONVILLE BUDGET ORDINANCE) BY AMENDING THE JTA BUDGET REVISED SCHEDULES O AND P; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Jacksonville Transportation Authority (JTA) has had a practice of amending their Council approved budget to reflect the actual revenues and expenditures of the JTA; and

WHEREAS, JTA has presented actual revenues and expenditures which affect the City of Jacksonville consolidated budget for the City of Jacksonville fiscal years 2018-19, budget ordinance 2018-504-E respectively; and

WHEREAS, on December 10, 2019, JTA approved Resolution 2019-35 recommending amending Ordinance 2018-504-E, which amends the Fiscal Year 2018-2019 JTA budget, such resolution being attached hereto as Exhibit 1;

WHEREAS, Revised Schedules O and P of JTA's Operations Budget, is amended to transfer from the Bus Division to cover operating costs in the CTC Division in the amount of \$1,527,823 due to the increase

in fuel and regional services to Clay county, and an increase of \$232,600 in the Ferry Division due to unexpected repairs to the Ferry; and

WHEREAS, JTA has presented actual revenues and expenditures which affect the City of Jacksonville consolidated budget for the City of Jacksonville fiscal years 2019-2020, budget ordinance 2019-504-E respectively; and

WHEREAS, on January 14, 2021, JTA approved Resolution 2021-01 recommending amending Ordinance 2019-504-E, which amends the Fiscal Year 2019-2020 JTA budget, such resolution being attached hereto as Exhibit 2;

WHEREAS, the Revised Schedules O and P of JTA's Operations Budget, is amended due to transfers from CARES Act funding to the Bus Division in the amount of \$627,461 due to the increase in expenses from the COVID-19 pandemic and Ultimate Urban Circulator (U2C) project management related expenses; an additional transfer of \$491,740 to the Skyway Division from the Bus Division due to an increase in expenses from additional maintenance costs and expenses related to the transition into the Jacksonville Regional Transportation Center (JRTC) and increased cleaning due to the pandemic; and \$712,443 in the General Fund/Engineering Division due to an increase in interest income revenue from investments used on relocation costs for the JRTC, required system evaluations and construction-related costs not covered by a grant; now therefor

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amendment of Ordinance 2018-504-E to Revise JTA Schedules for the 2018-2019 Budget. Sections 5.1 and 5.2 of Ordinance 2018-504-E are amended, in part, to revise Revised Schedules O and P to the JTA budget. Second Revised Schedules O and P, collectively attached hereto Exhibit 3, are by this reference, made a part of Ordinance 2018-504-E.

Section 2. Amendment of Ordinance 2019-504-E to Revise JTA Schedules for the 2019-2020 Budget. Sections 5.1 and 5.2 of Ordinance 2019-504-E are amended, in part, to revise Revised Schedules O and P to the JTA budget. Second Revised Schedules O and P, collectively attached hereto as Exhibit 4, are by this reference, made a part of Ordinance 2019-504-E.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor, or upon becoming effective without the Mayor's signature.
