

Business Impact Estimate

AN ORDINANCE APPROPRIATING \$25,000 FROM THE MULTIYEAR PROGRAMS AND INITIATIVES – COUNCIL DISTRICT 05 COMMUNITY BENEFITS AGREEMENT – CONTINGENCY ACCOUNT TO THE GENERAL FUND OPERATING – SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT TO PROVIDE FUNDING TO HAPPY BREW, INC. (“HAPPY BREW”) FOR THE ART FORCE VOCATIONAL TRAINING PROGRAM (THE “PROGRAM”) AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER TO FISCAL YEAR 2026-2027; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS; WAIVER AND DISCLOSURES), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO ALLOW FOR A DIRECT CONTRACT WITH HAPPY BREW; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND HAPPY BREW, INC. FOR THE PROGRAM; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.
