## ORDINANCE 2024-805

AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A RELEASE OF THE REGULATORY AGREEMENT ENCUMBERING PROPERTY LOCATED GENERALLY AT 4832 N. MAIN STREET, JACKSONVILLE, DUVAL COUNTY, FLORIDA, 32206 ("CAPRI VILLAS PROPERTY") WHICH IS A PORTION OF THE PROPERTY ASSOCIATED WITH THE CAPRI VILLAS PROJECT AND THE HURON SOPHIA PROJECT ("PROJECT") LOCATED GENERALLY AT THE CAPRI VILLAS PROPERTY AND 2800 SOPHIA STREET, JACKSONVILLE, DUVAL COUNTY, FLORIDA, 32254, (TOGETHER, "PROPERTY"), FOR THE PURPOSE OF ENABLING THE DEVELOPMENT OF THE PROJECT, INCLUDING THE ACQUISITION AND REHABILITATION OF EXISTING MULTIFAMILY RESIDENTIAL HOUSING FACILITIES FOR PERSONS OR FAMILIES OF LOW, MIDDLE OR MODERATE INCOME, SUBJECT TO (1) THE EXECUTION AND RECORDING OF A LAND USE RESTRICTION AGREEMENT (LURA) FOR A MINIMUM OF FIFTY (50) YEARS ON THE PROPERTY, AND (2) THE PROJECT BEING RESPONSIBLE FOR PAYING ALL COSTS ASSOCIATED THEREWITH, INCLUDING ALL LEGAL AND PROFESSIONAL FEES; AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND CORPORATION SECRETARY TO EXECUTE AND DELIVER DOCUMENTS AND TAKE FURTHER ACTION TO EFFECTUATE THE PURPOSE OF THIS ORDINANCE;

PROVIDING FOR CITY OVERSIGHT BY THE HOUSING AND COMMUNITY DEVELOPMENT DIVISION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, a portion of the Property is subject to that certain Regulatory Agreement recorded at Official Records Book 5823, Page 1859, as amended by that certain Amendment to Regulatory Agreement recorded at Official Records Book 6175, Page 910, of the Public Records of Duval County, Florida (the "Regulatory Agreement"); and

WHEREAS, SAH HSCV Holdings LP, a Florida limited partnership, and its permitted successors and assigns, (together, "Owner"), desire to develop and construct the Project on the Property; and

WHEREAS, in connection with the Project financing, the Jacksonville Housing Finance Authority is requiring Owner to record a minimum 50 year Land Use Restriction Agreement (LURA) placing additional restrictions on the Property related to the public purpose of assisting persons or families of low, moderate or middle income within Duval County to afford the costs of decent, safe and sanitary housing; and

WHEREAS, passage of this Ordinance by the Council will release the Regulatory Agreement from the Property, thereby enabling the Project to be developed, subject to the LURA being recorded and the Project paying for all costs associated therewith; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Approval and authorization. There is hereby approved, and the Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City, a termination and release of the Regulatory Agreement in substantially the form attached hereto as Exhibit 1, and all such other documents necessary or appropriate to effectuate the purpose of this Ordinance for the purpose of releasing the Regulatory

Agreement. This approval, however, is subject to execution and recording of the LURA by Owner for a minimum of fifty (50) years on the Property in substantially the form attached hereto as **Exhibit 2**, and the Project being responsible for paying all costs associated therewith, including all legal and professional fees.

Section 2. Authorization. The Mayor, or her designee, and Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, all documents necessary or appropriate to effectuate the purpose of this Ordinance and take, or cause to be taken, for and on behalf of the City, such further action to effectuate the purpose of this Ordinance.

Section 3. Oversight Department. The Housing and Community Development Division shall oversee the LURA and project described herein.

Section 4. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
