6 AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT
7 OF PALECIA CRAWFORD-MADDOX, A DUVAL COUNTY
8 RESIDENT, REPLACING LEOLA WILLIAMS, AS A CITIZEN
9 MEMBER THAT LIVES WITHIN ONE MILE OF THE CRA
10 BOUNDARY REPRESENTING THE GENERAL PUBLIC,
11 PURSUANT TO SECTION 53.202 (MEMBERSHIP;
12 APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART
13 2 (KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT

16 *ORDINANCE CODE*, FOR A PARTIAL TERM TO EXPIRE ON
17 DECEMBER 31, 2025; WAIVING SECTION 53.202
18 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF
19 OFFICE), PART 2 (KINGSOUTEL CROSSING COMMUNITY
20 REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53
21 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY
22 BOARDS) TO ALLOW APPOINTMENT OF A CITIZEN WHO
23 DOES NOT LIVE WITHIN ONE MILE OF THE CRA
24 BOUNDARY; PROVIDING AN EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appointment.** The Council hereby confirms the
28 Mayor's appointment of Palecia Crawford-Maddox, a Duval County
29 resident, replacing Leola Williams, to the KingSoutel Crossing
30 Community Redevelopment Agency Advisory Board, as a citizen member
31 that lives within one mile of the CRA boundary representing the

1 general public, pursuant to section 53.202 (Membership; appointment
2 and removal; terms of office), Part 2 (KingSoutel Crossing Community
3 Redevelopment Agency Advisory Board), Chapter 53 (Community
4 Redevelopment Agency Advisory Boards), *Ordinance Code*, for a partial
5 term to expire on December 31, 2025.

6 **Section 2. Waiving Section 53.202 (Membership; appointment**
7 **and removal; terms of office), Part 2 (KingSoutel Crossing Community**
8 **Redevelopment Agency Advisory Board), Chapter 53 (Community**
9 **Redevelopment Agency Advisory Boards), *Ordinance Code*.** The
10 provisions of Section 53.202 (Membership; appointment and removal;
11 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment
12 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency
13 Advisory Boards), *Ordinance Code*, are hereby waived to allow for Ms.
14 Crawford-Maddox's appointment even though she does not live within
15 one mile of the CRA boundary. The City finds that Ms. Crawford-Maddox
16 has acquired significant experience within the Northside community
17 which would be beneficial to the Advisory Board and City.

18 **Section 3. Effective Date.** This Ordinance shall become
19 effective upon signature by the Mayor or upon becoming effective
20 without the Mayor's signature.
