5 AN ORDINANCE APPROPRIATING \$223,096.20 IN
6 CORONAVIRUS RESPONSE AND RELIEF SUPPLEMENTAL
7 APPROPRIATIONS ACT (2021) (THE "ACT") PASS-
8 THROUGH GRANT FUNDS FROM THE UNITED STATES
9 DEPARTMENT OF HEALTH AND HUMAN SERVICES,
10 DISTRIBUTED BY THE NORTHEAST FLORIDA AREA
11 AGENCY ON AGING, INC. D/B/A ELDESOURCE
12 ("ELDESOURCE") TO THE CITY OF JACKSONVILLE,
13 TO BE USED TO PREVENT, PREPARE FOR, AND
14 RESPOND TO THE CORONAVIRUS PANDEMIC ("COVID-
15 19") BY PROVIDING NUTRITION SERVICES TO
16 ELIGIBLE INDIVIDUALS AGE 60 AND OLDER AND
17 OTHER ELIGIBLE PERSONS AS OUTLINED IN THE ACT
18 AND IN ACCORDANCE WITH ELDESOURCE'S
19 CORONAVIRUS CONSOLIDATED APPROPRIATIONS ACT
20 PROGRAM, AS INITIATED BY B.T. 21-071; PURPOSE
21 OF APPROPRIATION; PROVIDING FOR OVERSIGHT BY
22 THE SENIOR SERVICES DIVISION OF THE PARKS,
23 RECREATION AND COMMUNITY SERVICES DEPARTMENT;
24 PROVIDING FOR AN EFFECTIVE DATE.

26 **BE IT ORDAINED** by the Council of the City of Jacksonville:

27 **Section 1. Appropriation.** For the 2020-2021 fiscal year,
28 within the City's budget, there is hereby appropriated the
29 indicated sum from the account(s) listed in subsection (a) to the
30 account(s) listed in subsection (b):

6 (c) Explanation of Appropriation:

7 The funding above represents an appropriation of
8 Coronavirus Response and Relief Supplemental
9 Appropriations Act pass-through funding from the U.S.
10 Department of Health and Human Services and distributed
11 by Eldersource to be used to prevent, prepare for, and
12 respond to COVID-19 by providing nutrition services to
13 eligible individuals as outlined in the Act and in
14 accordance with the terms of Eldersource's Coronavirus
15 Consolidated Appropriations Act Program (the "Program").
16 These funds may be used to reimburse the City for any
17 goods and/or services provided pursuant to the Act and
18 the Program during the grant period commencing February
19 1, 2021 through September 30, 2022. No City match is
20 required.

21 **Section 2. Purpose.** The purpose of the appropriation in
22 Section 1 is to provide nutrition services to eligible individuals
23 in accordance with the Act and the Program for the period of
24 service commencing February 1, 2021 through September 30, 2022.
25 Nutrition services include the provision of congregate and home-
26 delivered meals, nutrition education and counseling, shopping
27 assistance and telephone reassurance. The Program is designed to
28 primarily serve persons aged 60 or older who are unable to obtain
29 well-balanced, nutritious meals due to a variety of reasons.
30 Specific attention is given to low-income individuals, including
31 low-income minority individuals and other individuals with limited
