30 initial funding of the Jacksonville Journey Forward  
31 initiative.

1           **Section 2.           Purpose.**   The purpose of the appropriation in  
2 Section 1 is to appropriate funding previously appropriated for Cure  
3 Violence contracts to provide the initial funding for the Jacksonville  
4 Journey Forward initiative.

5           **Section 3.           Carryover.**   The funds appropriated in this  
6 Ordinance shall not lapse but shall carryover to fiscal year 2024-  
7 2025.

8           **Section 4.           Effective Date.**   This Ordinance shall become  
9 effective upon signature by the Mayor or upon becoming effective  
10 without the Mayor's signature.
