4 **ORDINANCE 2020-175**

5 AN ORDINANCE ADOPTING A MODIFICATION TO THE
6 CITY OF JACKSONVILLE *2030 COMPREHENSIVE PLAN*
7 FOR THE PURPOSE OF UPDATING THE CAPITAL
8 IMPROVEMENTS ELEMENT SCHEDULE BY ESTABLISHING
9 THE FISCAL YEARS 2020-2024 CAPITAL
10 IMPROVEMENTS ELEMENT SCHEDULE IN THE CAPITAL
11 IMPROVEMENTS ELEMENT; PROVIDING AN EFFECTIVE
12 DATE.

14 **WHEREAS**, a modification of the 5-Year Capital Improvements
15 Element Schedule contained in the Capital Improvements Element of
16 the City of Jacksonville *2030 Comprehensive Plan* has been initiated
17 by the Planning and Development Department, which modification is
18 more particularly set forth in **Exhibit 1, attached hereto**; and

19 **WHEREAS**, the City Council enacted Ordinance 2019-505-E for the
20 Fiscal Years 2020-2024 Capital Improvement Plan, and the Capital
21 Improvements Element Schedule is a subset of the City's approved
22 Capital Improvement Plan; and

23 **WHEREAS**, projects within the Capital Improvements Element
24 Schedule may be funded by local, regional, state or federal
25 governments, or may be privately funded, and therefore, the Capital
26 Improvements Element Schedule includes projects from the North
27 Florida Transportation Planning Organization's Transportation
28 Improvement Plan and Long Range Transportation Plan, as well as the
29 City of Jacksonville's 2030 Mobility Plan; and

30 **WHEREAS**, pursuant to Section 163.3177(3) (b), *Florida Statutes*,
31 the City of Jacksonville may modify the *2030 Comprehensive Plan* to

1 update the 5-year Capital Improvements Element Schedule by
2 Ordinance, and such modification is not deemed an amendment to the
3 *2030 Comprehensive Plan*; now, therefore

4 **BE IT ORDAINED** by the Council of the City of Jacksonville:

5 **Section 1. Modification to 2030 Comprehensive Plan.** The
6 Capital Improvements Element of the City of Jacksonville *2030*
7 *Comprehensive Plan* is hereby modified to update the Capital
8 Improvements Element Schedule to establish the Fiscal Years 2020-
9 2024 Capital Improvements Element Schedule, as more particularly
10 set forth in **Exhibit 1, attached hereto**. The Planning and
11 Development Department is authorized to include all updates to the
12 Capital Improvement Plan (CIP) approved by the City Council,
13 through the date of enactment of this Ordinance, in the Capital
14 Improvements Element Schedule, and shall place the final Capital
15 Improvements Element Schedule in the file with the City Council
16 Legislative Services Division, and upon ADA compliance, shall
17 publish the final Capital Improvements Element Schedule on the
18 City's website as part of the Capital Improvements Element of the
19 *2030 Comprehensive Plan*.

20 **Section 2. Effective Date.** This Ordinance shall become
21 effective upon the signature by the Mayor or upon becoming
22 effective without the Mayor's signature.
