The ordinance involves the installment, by the City, of a new street sign to honor the late Tiphne D. Hollis because she lived in Jacksonville within 5 miles of the proposed new street name for a very short period of time. Ms. Hollis died, tragically, at the young age of 16. Family and friends have opened a Christian learning academy to honor Ms. Hollis' short but vibrant legacy, and the academy is already in operation and located on the proposed new street name.
