This position is appointed by the Mayor, subject to confirmation by the Council and shall serve at the pleasure of the Mayor.

This position reports to the Emergency Preparedness Director or Director of Fire and Rescue and is responsible for the organization, administration, and operations of the Emergency Preparedness Division, Primary responsibilities include the following:

- Coordinates the activities, services and programs for emergency management and disaster response within Duval County and shall be the point of contact with other emergency management organizations.
- Prepares a Comprehensive Emergency Management Plan and program for Duval County pursuant to Chapter 252, Florida Statutes. (Mitigation activities, preparedness, responses to disasters and emergencies, and recovery operations).
- Monitors and advises the Directors of Employee Preparedness or the Director of Fire and Rescue of any and all threats, emergencies, or disasters that pose a risk to the lives and safety of Duval County residents and proposes solutions on how to best protect people and property from imminent danger or further damage.
- Procures supplies and equipment, institutes training programs, public preparedness information and education programs, manages and coordinates disaster drills and exercises in accordance with the Plan.
- Develops evacuation plan for Duval County to be utilized for all types of emergencies or disasters and in collaboration with local entities, municipalities, concerned agencies, public utilities, and state offices.
- Ensures all 214 Forms and other required applications/documentation are properly completed and submitted during times of declared or other emergencies that could result in the recovery of Federal/State funding and works with appropriate City, State, or Federal partners to ensure timely cost recoveries.
- Communicates clear direction, manages for results, and leads organizational change.
- Assigns responsibility, takes corrective action, demonstrates leadership and evaluates, develops and motivates employees.

**Position Requirements:** Shall have at least five years' experience in the administration, training or management of firefighting, emergency medical or rescue personnel, equipment, and apparatus.
