5 AN ORDINANCE REGARDING PARKING RATES FOR CITY
6 EMPLOYEES; AMENDING SUB-PARAGRAPH (D) TO
7 SECTION 122.202 (PARKING RATES AT MUNICIPAL
8 PARKING LOTS) TO EXTEND THE DISCOUNT RATE TO
9 EMPLOYEES PARKING IN CITY OWNED PARKING
10 FACILITIES FOR AN ADDITIONAL ONE YEAR;
11 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
12 PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Amending sub-paragraph (d) to Section 122.202**
16 **(Parking Rates at Municipal Parking Lots), Ordinance Code.** Chapter
17 122 (Public Property), Part 2 (Municipal Parking Lots), Section
18 122.202 (Parking rates at municipal parking lots), *Ordinance Code*,
19 is hereby amended to read as follows:

20 **CHAPTER 122 PUBLIC PROPERTY.**

22 **PART 2. MUNICIPAL PARKING LOTS**

24 **Sec. 122.202 (Parking rates at municipal parking lots).**

26 (d) Effective October 1, 2014, all City employees (which term
27 shall include all City of Jacksonville employees and employees of
28 the Duval County Supervisor of Elections, Duval County Property
29 Appraiser, Duval County Tax Collector, and Duval County Clerk of
30 Court, who are monthly parkers at municipal owned parking
31 facilities operated by the Office of Public Parking, shall be

1 entitled to a reduced monthly parking rate, which shall be fifty
2 percent (50%) of the established, monthly parking rate for the
3 given facility for a seven (7) ~~six (6)~~ year duration and end as of
4 September 30, 2021~~0~~. The Economic Development Officer shall file
5 the employee rate schedule and any subsequent change to the
6 employee rate schedule with the Council Secretary, and such rates
7 shall become effective upon such filing unless and until the
8 Council enacts an ordinance to the contrary.

9 **Section 2. Requesting one cycle emergency passage**
10 **pursuant to Council Rule 4.901 Emergency.** One cycle emergency
11 passage of this legislation is requested. The nature of the
12 emergency is that the existing reduced monthly parking rate for
13 existing employees is set to expire on September 30, 2020 and the
14 DIA desires the extension authorized hereby to be effective prior
15 to the expiration date.

16 **Section 3. Effective Date.** This ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
