WHEREAS, the City of Jacksonville (the "City") and Lutheran Services Florida, Inc. ("LSF") entered into that certain Subaward Agreement for COPS Community Policing Development Crisis Intervention Teams Program, effective March 15, 2022 (the "Agreement"), as authorized by 2022-27-E, to provide grant funding for a Co-Responder (Crisis Intervention) Team consisting of a clinician and a sworn law enforcement officer working together to respond to non-violent health-related calls for service, engage in specialized assignments from zone commanders, and conduct proactive outreach in the community; and

WHEREAS, the Agreement provided for an initial term through August 31, 2023, with one, one-year extension option; and

WHEREAS, due to unanticipated hiring delays and resignations of the clinicians, the City and LSF extended the term of the Agreement to August 31, 2024, to accomplish the purposes of the Agreement. At present, however, the Agreement is expired but funds remain available thereunder;
