AN ORDINANCE APPROPRIATING \$25,000.00 FROM THE SPECIAL LAW ENFORCEMENT TRUST FUND FOR DONATION TO FIRST COAST CRIME STOPPERS, INC., ACCORDANCE WITH SECTION 932.7055(5), FLORIDA STATUTES, TO SUPPORT DRUG TREATMENT, DRUG ABUSE EDUCATION, DRUG PREVENTION, CRIME PREVENTION, SAFE NEIGHBORHOOD, AND SCHOOL RESOURCE OFFICER PROGRAM(S), AS INITIATED BY B.T. 23-099; APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY EXECUTE AND DELIVER ON BEHALF OF THE CITY THAT CERTAIN MISCELLANEOUS APPROPRIATIONS AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND FIRST COAST CRIME STOPPERS, INC.; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR ADVANCE PAYMENT TO FIRST COAST CRIME STOPPERS, INC.; PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.
