6 AN ORDINANCE APPROPRIATING \$25,000.00 FROM THE  
7 SPECIAL LAW ENFORCEMENT TRUST FUND FOR DONATION  
8 TO FIRST COAST CRIME STOPPERS, INC., IN  
9 ACCORDANCE WITH SECTION 932.7055(5), *FLORIDA*  
10 *STATUTES*, TO SUPPORT DRUG TREATMENT, DRUG ABUSE  
11 EDUCATION, DRUG PREVENTION, CRIME PREVENTION,  
12 SAFE NEIGHBORHOOD, AND SCHOOL RESOURCE OFFICER  
13 PROGRAM(S), AS INITIATED BY B.T. 23-099;  
14 APPROVING AND AUTHORIZING THE MAYOR, OR HER  
15 DESIGNEE, AND THE CORPORATION SECRETARY TO  
16 EXECUTE AND DELIVER ON BEHALF OF THE CITY THAT  
17 CERTAIN MISCELLANEOUS APPROPRIATIONS AGREEMENT  
18 BETWEEN THE CITY OF JACKSONVILLE AND FIRST COAST  
19 CRIME STOPPERS, INC.; WAIVING SECTION 110.112  
20 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST),  
21 PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY  
22 TREASURY), *ORDINANCE CODE*, TO ALLOW FOR ADVANCE  
23 PAYMENT TO FIRST COAST CRIME STOPPERS, INC.;  
24 PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE  
25 SHERIFF'S OFFICE; PROVIDING AN EFFECTIVE DATE.

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Appropriation.** For the 2022-2023 fiscal year,  
29 within the City's budget, there is hereby appropriated the indicated  
30 sum(s) from the account(s) listed in subsection (a) to the account(s)  
31 listed in subsection (b):

7 (c) Explanation of Appropriation:

8 The funding above represents an appropriation of \$25,000.00  
9 from the Special Law Enforcement Trust Fund for donation  
10 to First Coast Crime Stoppers, Inc., to support drug  
11 treatment, drug abuse education, drug prevention, crime  
12 prevention, safe neighborhood, and/or school resource  
13 officer programs administered by that entity in accordance  
14 with Section 932.7055(5), *Florida Statutes*.

15 **Section 2. Purpose.** The purpose of the appropriation in  
16 Section 1 is to provide a donation to First Coast Crime Stoppers,  
17 Inc. This allocation supports drug treatment, drug abuse education,  
18 drug prevention, crime prevention, safe neighborhood, and/or school  
19 resource officer programs for the citizens of the City of  
20 Jacksonville. A Certification from the Jacksonville Sheriff's Office  
21 that the subject appropriation from the Special Law Enforcement Trust  
22 Fund complies with Section 932.7055, *Florida Statutes*, is attached  
23 hereto as **Exhibit 2** and incorporated herein by this reference.

24 **Section 3. Approval and Authorization.** There is hereby  
25 approved, and the Mayor, or her designee, and the Corporation  
26 Secretary are hereby authorized to execute and deliver on behalf of  
27 the City that certain Miscellaneous Appropriations Agreement between  
28 the City of Jacksonville and First Coast Crime Stoppers, Inc., in  
29 substantially the same form placed **On File** with the Legislative  
30 Services Division (the "Agreement").

31 **Section 4. Waiving Section 110.112, Ordinance Code.**

1 Section 110.112 (Advance of city funds; prohibition against), Part 1  
2 (The City Treasury), Chapter 110 (City Treasury), *Ordinance Code*, is  
3 hereby waived to allow for advance payment to First Coast Crime  
4 Stoppers, Inc., as provided in the Agreement.

5 **Section 5. Oversight.** The Jacksonville Sheriff's Office  
6 shall oversee the Agreement described herein.

7 **Section 6. Effective Date.** This Ordinance shall become  
8 effective upon signature by the Mayor or upon becoming effective  
9 without the Mayor's signature.
