Please provide authorization for the Public Works Real Estate Division to request the legislation necessary for the Mayor to execute a Sovereignty Submerged Lands Lease Modification, BOT No. 160336982, from the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida, in substantially the same form as the attached. The boat ramp is located at 6359 Heckscher Drive. See maps attached and RE# 160803-0100 for location purposes.

The lease renewal term extends through August 30, 2034, and specifies an initial annual lease fee of \$5,445.91 and is adjusted pursuant to Florida Administrative Code 18-21.011. The original lease incorporates Palms Fish Camp Restaurant LLC as a commercial user of the property, thereby requiring the City to pay an annual lease fee. The purpose of this lease is to operate a 21-slip commercial docking facility, an existing boat ramp, a canoe/kayak launch, and an additional boat ramp with boardwalks on either side of the ramp.

This lease is at the request of the Parks, Recreation, and Community Services Department.




