## **ORDINANCE 2025-72**

AN ORDINANCE APPROPRIATING \$200,000 FROM A GENERAL FUND OPERATING DESIGNATED CONTINGENCY ACCOUNT TO THE GENERAL FUND OPERATING SUBSIDIES AND CONTRIBUTIONS TO PRIVATE ORG ACCOUNT, TO PROVIDE CITY GRANT FUNDING TO THE JACKSONVILLE FRATERNAL ORDER OF POLICE FOUNDATION, INC. ("FOP FOUNDATION") TO SUPPORT VARIOUS CHARITABLE AND EDUCATIONAL INITIATIVES AS DESCRIBED HEREIN; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH FOP FOUNDATION; WAIVING SUBSECTION 118.301(A)(3)(III) (EXPENDITURE OF APPROPRIATED FUNDS), PART 3 (ADMINISTRATION OF CITY GRANTS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOP FOUNDATION TO USE A PORTION OF THE CITY GRANT FUNDS FOR CONTRIBUTIONS AND DONATIONS TO OTHER GROUPS OR ORGANIZATIONS; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY A GRANT AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND FOP FOUNDATION; PROVIDING FOR OVERSIGHT BY THE GRANTS AND CONTRACT COMPLIANCE DIVISION OF THE FINANCE DEPARTMENT; PROVIDING AN EFFECTIVE DATE.
