5 AN ORDINANCE APPROPRIATING \$594,636.00 FROM FIRE
6 OPERATIONS & FIRE CONTROL LEAVE SELLBACK TO THE
7 ADMINISTRATIVE SERVICES - FIRE CONTROL PROJECT
8 (THE "PROJECT") TO PURCHASE FOAM FOR FIRE
9 SUPPRESSION ACTIVITIES; PROVIDING FOR REVERTER
10 OF FUNDS; REQUESTING EMERGENCY PASSAGE UPON
11 INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

13 **BE IT ORDAINED** by the Council of the City of Jacksonville:

14 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
15 within the City's budget, there are hereby appropriated the indicated
16 sum(s) from the account(s) listed in subsection (a) to the account(s)
17 listed in subsection (b):

24 **Explanation of Appropriation:**

25 The funding above represents an appropriation of funds from
26 the Fire Operations - Fire Control Leave Sellback to the
27 Administrative Service - Fire Control Project (the
28 "Project") to purchase foam for fire suppression
29 activities.

30 **Section 2. Purpose.** The purpose of the appropriation in
31 Section 1 is to purchase foam for fire suppression activities. The

1 vast majority of JFRD's bulk foam supply was used to assist with the
2 Brunswick, Georgia fire on April 15, 2023 and must be replaced in
3 case there is another industrial fire locally.

4 **Section 3. Reverter.** Any remaining funds after the
5 completion of the Project shall be returned to the account of origin.

6 **Section 4. Requesting emergency passage upon introduction**
7 **pursuant to Council Rule 4.901.** Emergency passage upon introduction
8 of this ordinance is requested due to the depletion of most of JFRD's
9 fire suppression foam in assisting with the Brunswick, Georgia fire
10 on April 15, 2023. JFRD needs to move expeditiously to replenish its
11 supply of fire suppression foam to assist with any local industrial
12 fires that may occur.

13 **Section 5. Effective Date.** This Ordinance shall become
14 effective upon signature by the Mayor or upon becoming effective
15 without the Mayor's signature.
