4 **ORDINANCE 2019-559-E**

5 AN ORDINANCE AUTHORIZING AND DIRECTING THE  
6 MAYOR AND CORPORATION SECRETARY TO EXECUTE AN  
7 ADDITIONAL MODIFICATION TO AN AGREEMENT  
8 AMENDING THE SETTLEMENT AGREEMENT DATED MARCH  
9 1, 1994, AMONG B&B ADVERTISING COMPANY,  
10 CAPSIGNS AND THE CITY OF JACKSONVILLE;  
11 PROVIDING AN EFFECTIVE DATE.

13 **WHEREAS**, the City of Jacksonville, Capsigns, Inc., and B&B  
14 Advertising Company entered into a settlement agreement dated March  
15 1, 1994 (the "1994 Agreement"), resolving litigation concerning the  
16 City's billboard regulations; and

17 **WHEREAS**, on July 14, 2000, the City of Jacksonville, Scenic  
18 Jacksonville, Inc. d/b/a Capsigns, Inc., and Wesley A. Miner, owner  
19 of B&B Advertising Company, Inc., agreed to certain modifications  
20 to the 1994 Agreement resulting in more billboards being removed  
21 than was required under the 1994 Agreement; and

22 **WHEREAS**, the City of Jacksonville, Scenic Jacksonville, Inc.  
23 d/b/a Capsigns, Inc., and Wesley A. Miner, owner of B&B Advertising  
24 Company, Inc., have agreed to an additional modification to the  
25 1994 Agreement that, among other things, will result in more  
26 billboards being removed than was required under the 1994  
27 Agreement; and

28 **WHEREAS**, the City Council finds it to be in the best interest  
29 of the City to agree to the terms in the proposed Additional  
30 Modification to Agreement; now therefore

31 **BE IT ORDAINED** by the Council of the City of Jacksonville:

1           **Section 1.       Approval of Modification.**    The proposed  
2 Additional Modification to Agreement (attached to which are the  
3 1994 and 2000 Agreements), attached hereto as **Exhibit 1**, is hereby  
4 approved and the Mayor and Corporation Secretary are hereby  
5 authorized and directed to execute the Additional Modification to  
6 Agreement on behalf of the City.

7           **Section 2.       Effective Date.**    This ordinance shall become  
8 effective upon signature of the Mayor or upon becoming effective  
9 without the Mayor's signature.
