

BUSINESS IMPACT ESTIMATE

ORDINANCE 2024-714

AN ORDINANCE APPROPRIATING \$120,000 FROM THE ECONOMIC GRANT PROGRAM, MISCELLANEOUS NON DEPARTMENTAL EXPENDITURES ACCOUNT TO THE MUNICIPAL DUES AND AFFILIATIONS – CHAMBER OF COMMERCE, DUES AND SUBSCRIPTIONS ACCOUNT TO PROCURE THE PROFESSIONAL SERVICES OF JACKSONVILLE REGIONAL CHAMBER OF COMMERCE, INC. (“JAX CHAMBER”) TO ATTRACT AND RETAIN KEY BUSINESS HEADQUARTERS IN DOWNTOWN JACKSONVILLE AS DESCRIBED HEREIN; PROVIDING FOR CARRYOVER TO SEPTEMBER 30, 2025; WAIVING SECTION 110.112 (ADVANCE OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE CITY TREASURY), CHAPTER 110 (CITY TREASURY), ORDINANCE CODE, TO ALLOW FOR QUARTERLY PAYMENTS TO JAX CHAMBER; INVOKING THE EXEMPTION IN SECTION 126.108(G) (EXEMPTIONS FROM COMPETITIVE SOLICITATION), PART 1 (GENERAL REGULATIONS; ETHICS AND TRANSPARENCY IN PUBLIC CONTRACTING), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH JAX CHAMBER; WAIVING SECTION 118.107 (NONPROFITS TO RECEIVE FUNDING THROUGH A COMPETITIVE EVALUATED AWARD PROCESS), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH JAX CHAMBER; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER ON BEHALF OF THE CITY AN AGREEMENT BETWEEN THE CITY OF JACKSONVILLE AND JACKSONVILLE REGIONAL CHAMBER OF COMMERCE, INC.; PROVIDING FOR OVERSIGHT BY THE OFFICE OF ECONOMIC DEVELOPMENT; PROVIDING AN EFFECTIVE DATE.
