FOR A POINT OF REFERENCE BEGIN AT THE INTERSECTION OF THE CURRENT SOUTHERLY RIGHT-OF-WAY LINE OF FORT CAROLINE ROAD (A VARIABLE WIDTH RIGHT-OF-WAY AS NOW ESTABLISHED) WITH THE WESTERLY RIGHT-OF-WAY LINE OF PEELER ROAD (A 66 FOOT RIGHT-OF-WAY AS NOW ESTABLISHED); THENCE SOUTH 74°40'38" WEST ALONG SAID SOUTHERLY RIGHT-OF-WAY LINE OF SAID FORT CAROLINE ROAD, A DISTANCE OF 320.92 FEET TO THE POINT OF BEGINNING; THENCE DEPARTING SAID SOUTHERLY RIGHT-OF-WAY LINE SOUTH 15°19'23" EAST, A DISTANCE OF 414.00 FEET; THENCE NORTH 74°40'38" EAST, A DISTANCE OF 321.32 FEET TO THE AFOREMENTIONED CURRENT WESTERLY RIGHT-OF-WAY LINE OF PEELER ROAD; THENCE SOUTH 15"23'06" EAST, ALONG SAID WESTERLY RIGHT OF WAY LINE, A DISTANCE OF 131.02 FEET; THENCE SOUTH 74°40'13" WEST.
