A RESOLUTION HONORING AND COMMENDING DR. MICHAEL GEORGE, PRINCIPAL OF ATLANTIC COAST HIGH SCHOOL, ON THE OCCASION OF HIS RECEIVING FLORIDA'S 2024 PRINCIPAL ACHIEVEMENT AWARD FOR OUTSTANDING LEADERSHIP FROM THE FLORIDA DEPARTMENT OF EDUCATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Dr. Michael George began his career in education in 2005 as a social studies teacher and basketball coach at Martin Luther King High School in Philadelphia, worked as a principal in New Orleans, and has served as principal of Atlantic Coast High School for the past three years; and

WHEREAS, Atlantic Coast High School has flourished under Dr. George's leadership, achieving a graduation rate of 95.3% and A-grade in 2023; and

WHEREAS, the Florida Department of Education named Dr. George as the recipient for the Principal Achievement Award for Outstanding Leadership for 2024, citing accomplishments such as founding a first-in-state medical pathway partnership with Mayo Clinic that

created two new career and technical education programs; spearheading a partnership with the University of North Florida with the goal of inspiring students to pursue a career in education; and launching an in-school program named "We Lead" that offers monthly sessions for teachers seeking leadership opportunities; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City Council hereby honors Dr. Michael George on his receipt of the 2024 Principal Achievement Award for Outstanding Leadership for the State of Florida and commends both Dr. George and Atlantic Coast High School on their efforts culminating in Dr. George's receipt of this award. Dr. George's servant leadership stands as an example to the rest of the school district and to the state, and the City Council expresses its support for the continued success of Atlantic Coast High School and of all Duval County Public Schools.
