Subsection 118.201(f)(7) (Release of Appropriations), Part 2 (Disbursement of City Grants), Chapter 118 (City Grants), Ordinance Code, is hereby waived to allow the grant funds to be disbursed to MWP in two advance payments of \$38,750 rather than on a reimbursement basis. This waiver is justified as it allows MWP to continue its outreach and revitalization efforts in Mayport Village recognizing it does not currently have the finances to support reimbursement-based payments.";

- (14) Renumber the remaining Section accordingly;
- (15) Remove On File and replace with Revised On File, attached hereto, which attaches the revised Amendment One to FY 2023-2025 City Grant Agreement Between the City of Jacksonville and Mayport Waterfront, Inc.;
- (16) On page 1, line 1, amend the introductory sentence to add that the bill was amended as reflected herein.
