AN ORDINANCE APPROPRIATING \$100,000 FROM THE COUNCIL PRESIDENT'S DESIGNATED CONTINGENCY TO THE COUNCIL STAFF SERVICES OTHER PROFESSIONAL SERVICES ACCOUNT TO PROCURE THE PROFESSIONAL SERVICES OF YELLOW DOG MEDIA, LLC, D/B/A WANDER MEDIA COMPANY ("WANDER MEDIA"), TO REBRAND AND RECONFIGURE THE CITY'S PUBLIC ACCESS CHANNEL (CHANNEL 99) AND TO DEVELOP A COMPANION DIGITAL STREAMING CHANNEL FOR VARIOUS STREAMING DEVICES AND CHANNELS; PROVIDING FOR CARRYOVER OF FUNDS TO FISCAL YEAR 2024-2025; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR A DIRECT CONTRACT WITH YELLOW DOG MEDIA, LLC, D/B/A WANDER MEDIA COMPANY; APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER A CONTRACT WITH WANDER MEDIA, FOR THE PROVISION OF PROFESSIONAL SERVICES RELATED TO CHANNEL 99 AND A COMPANION DIGITAL CHANNEL ON VARIOUS STREAMING DEVICES AND CHANNELS; PROVIDING FOR OVERSIGHT BY THE COUNCIL DIRECTOR; PROVIDING AN EFFECTIVE DATE.

(c) Explanation of Appropriation:

The funding above comprises an appropriation of \$100,000 from the Council President's Designated Contingency to the Council Staff Services Other Professional Services account to procure the professional services of Yellow Dog Media, LLC, d/b/a Wander Media Company ("Wander Media"), to rebrand and reconfigure the City's existing public access television channel (Channel 99) and to develop a companion digital channel that will live stream on various streaming devices and channels.

Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds to procure the professional services of Wander Media to identify and develop new and additional content for Channel 99 with the approval of the Council Director. This would include content related to public safety, elected official features, small and emerging businesses, arts and culture, parks and recreation, historical footage, emergency messaging, accessibility, and other areas of interest. Wander Media will work closely with Council staff to schedule and launch this content on both Channel 99 and will also develop a companion digital channel that will live stream on various streaming devices and channels such as Roku, Apple TV, YouTube TV and Amazon Fire.

Section 3. Carryover. The funds appropriated by this Ordinance shall not lapse but shall carryover to fiscal year 2024-2025.

Section 4. Invoking the Exemption in Section 126.107(g), Ordinance Code. The City is hereby authorized to procure the use of the professional services of Yellow Dog Media, LLC, d/b/a Wander Media Company, to provide the services described in Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Scope, May 6, 2024 - Rules" attached hereto and incorporated herein by this reference. Pursuant to Section 126.107(g) (Exemptions), Part 1 (General Regulations), Chapter 126 (Procurement Code), Ordinance Code, such procurement is exempt from competitive solicitation because the supplies or services are to be provided by those specifically prescribed within authorizing legislation that appropriates the same. With the exception of the foregoing, all other provisions of Chapter 126, Ordinance Code, shall remain in full force and effect.

Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver on behalf of the City an agreement with Yellow Dog Media, LLC, d/b/a Wander Media Company, in an amount not-to-exceed \$100,000, subject to the Scope of Services more particularly described in Revised Exhibit 2, for a term commencing on June 1, 2024 through May 31, 2025, and all other contracts and documents, including extensions, renewals and amendments to the agreement, and to otherwise take all action necessary to effectuate the intent of this Ordinance, subject to appropriate legal review and approval by the Office of General Counsel and the City's Risk Management Division for appropriate insurance and indemnification requirements in accordance with Section 128.601, Ordinance Code.

Section 6. Oversight. The Council Director shall oversee the project described herein.
