4 **ORDINANCE 2024-545**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER A FIRST
8 AMENDMENT TO FISCAL YEAR 2023-2024 CURE VIOLENCE
9 SERVICES CONTRACT BETWEEN THE CITY OF
10 JACKSONVILLE ("CITY") AND REINTEGRATION
11 SOLUTIONS, INC. OF JACKSONVILLE TO EXTEND THE
12 TERM AND AMEND THE PROGRAM BUDGET DETAIL;
13 PROVIDING FOR CITY OVERSIGHT BY THE GRANTS AND
14 CONTRACT COMPLIANCE DIVISION; PROVIDING AN
15 EFFECTIVE DATE.

17 **WHEREAS**, the City of Jacksonville (the "City") and Reintegration
18 Solutions, Inc. of Jacksonville ("Recipient"), previously entered
19 into that certain Fiscal Year 2023-2024 Cure Violence Services
20 Contract dated October 1, 2023 (the "Contract"), as authorized by
21 Ordinance 2023-504-E, to provide funding from the City to Recipient
22 in the amount of \$312,766.00 (the "Maximum Indebtedness") to be used
23 to implement the Cure Violence Public Health Violence Reduction Model
24 to interrupt violent conflicts and eliminate violence; and

25 **WHEREAS**, Recipient has requested to amend the Contract to adjust
26 the program budget detail in order to reallocate funding between
27 certain line items of the budget without increasing the Maximum
28 Indebtedness and extend the term of the Contract to allow the City
29 to make the final payment for services in accordance with the revised
30 program budget detail;

31 **WHEREAS**, the term of the Contract expired on January 31, 2024,

1 and Recipient has requested the City to enter into a First Amendment
2 to Fiscal Year 2023-2024 Cure Violence Services Contract in
3 substantially the form attached hereto as **Exhibit 1** and incorporated
4 herein by this reference (the "Amendment") having an effective date
5 of January 31, 2024 to revive the Contract and maintain contractual
6 continuity; now therefore

7 **BE IT RESOLVED** by the Council of the City of Jacksonville:

8 **Section 1. Approval and Authorization to Execute Amendment**
9 **to Contract.** There is hereby approved, and the Mayor, or her
10 designee, and the Corporation Secretary are hereby authorized to
11 execute and deliver, the Amendment. The Amendment amends certain line
12 items of the Budget/Fee Schedule and Complete Program Budget Detail
13 to reallocate funding to allow for unforeseen expenses and to correct
14 a discrepancy, without increasing the Maximum Indebtedness, and
15 extends the term of the Contract to allow the City to make the final
16 payment to Recipient for services under the Contract, with all other
17 terms and conditions of the Contract remaining unchanged.

18 **Section 2. Oversight Department.** The Grants and Contract
19 Compliance Division of the Finance Department shall continue to have
20 oversight of the Contract described herein.

21 **Section 3. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
